

SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Judiciary.

SB25-281 be amended as follows:

1 Amend printed bill, Page 3, lines 13 and 14, strike "person: ~~commits a~~  
2 ~~class 1 misdemeanor traffic offense.~~" and substitute "person ~~commits a~~  
3 ~~class 1 misdemeanor traffic offense.~~ RECEIVES TWELVE LICENSE  
4 SUSPENSION POINTS IN ACCORDANCE WITH SECTION 42-2-127 (5)(e.5) AND  
5 IS SUBJECT TO A SUSPENSION OF THEIR DRIVER'S LICENSE FOR A PERIOD OF  
6 UP TO ONE YEAR IN ACCORDANCE WITH SECTION 42-2-127 (1)(a) AND  
7 42-2-128 (2) AND:".

8 Page 3, strike lines 15 through 17 and substitute:

9 "(A) COMMITS A CLASS 1 MISDEMEANOR TRAFFIC OFFENSE UNLESS  
10 SUBSECTION (2)(c)(I)(B) OR (2)(c)(I)(C) OF THIS SECTION APPLIES;

11 (B) COMMITS A CLASS 6 FELONY IF THE PERSON HAS A PRIOR  
12 CONVICTION OF VEHICULAR HOMICIDE PURSUANT TO SECTION 18-3-106,  
13 CRIMINAL NEGLIGENT HOMICIDE PURSUANT TO SECTION 18-3-105 IN  
14 WHICH THE COMMISSION OF THE ACT INCLUDED DRIVING A MOTOR  
15 VEHICLE, VEHICULAR ASSAULT PURSUANT TO SECTION 18-3-205 (1)(b), OR  
16 CARELESS DRIVING RESULTING IN SERIOUS BODILY INJURY OR DEATH  
17 PURSUANT TO SUBSECTION (2)(b)(II) OF THIS SECTION OR THIS SUBSECTION  
18 (2)(c); OR

19 (C) COMMITS A CLASS 6 FELONY IF THE PERSON IS DRIVING  
20 WITHOUT A CURRENTLY VALID DRIVER'S LICENSE, MINOR DRIVER'S  
21 LICENSE, OR INSTRUCTION PERMIT IN VIOLATION OF SECTION 42-2-101 OR  
22 WITHOUT A COMPLYING INSURANCE POLICY OR SELF-INSURANCE IN  
23 VIOLATION OF SECTION 42-4-1409 AND IF THE PERSON HAS A PRIOR  
24 CONVICTION WITHIN THE LAST FIVE YEARS OF DUI, DUI PER SE, DWAI,  
25 AGGRAVATED DRIVING WITH A REVOKED A LICENSE PURSUANT TO SECTION  
26 42-2-206 (1)(b)(I), CARELESS DRIVING RESULTING IN BODILY INJURY  
27 PURSUANT TO SUBSECTION (2)(b)(I) OF THIS SECTION, OR DRIVING WHILE  
28 THE PERSON'S DRIVER'S LICENSE WAS UNDER RESTRAINT PURSUANT TO  
29 SECTION 42-2-138 (1)(d).".
