Second Reading

1 Amend printed bill, page 2, line 4, strike "(3)(d)" and substitute "(3)(d);
2 and **add** (5)".

3 Page 2, line 6, before "**rules.**" insert "**report -**".

4 Page 4, after line 12 insert:

5 "(5) BEGINNING IN 2026 AND EACH YEAR THEREAFTER, THE
6 DEPARTMENT SHALL SUBMIT THE FOLLOWING DATA TO THE SENATE
7 BUSINESS, LABOR, AND TECHNOLOGY COMMITTEE AND THE HOUSE OF
8 REPRESENTATIVES BUSINESS AFFAIRS AND LABOR COMMITTEE, OR THEIR
9 SUCCESSOR COMMITTEES, DURING THE HEARINGS HELD PURSUANT TO THE
10 "SMART ACT", PART 2 OF ARTICLE 7 OF TITLE 2:

11 (a) THE TOTAL NUMBER OF INDIVIDUALS TO WHOM THE
12 DEPARTMENT PROVIDED VOCATIONAL REHABILITATION SERVICES OVER
13 EACH OF THE TWO STATE FISCAL YEARS PRECEDING THE REPORT;

14 (b) THE TOTAL NUMBER OF INDIVIDUALS TO WHOM THE
15 DEPARTMENT PROVIDED VOCATIONAL REHABILITATION SERVICES OVER
16 THE STATE FISCAL YEAR PRECEDING THE REPORT WHO BECAME RESIDENTS
17 OF COLORADO DURING THAT STATE FISCAL YEAR, IF THAT DATA IS
18 AVAILABLE TO THE DEPARTMENT;

19 (c) THE TOTAL NUMBER OF INDIVIDUALS TO WHOM THE
20 DEPARTMENT PROVIDED VOCATIONAL REHABILITATION SERVICES OVER
21 THE STATE FISCAL YEAR PRECEDING THE REPORT WHO BECAME RESIDENTS
22 OF ANOTHER STATE DURING THAT STATE FISCAL YEAR, IF THAT DATA IS
23 AVAILABLE TO THE DEPARTMENT;

24 (d) THE TOTAL NUMBER OF FULL-TIME EQUIVALENT EMPLOYEES
25 PROVIDING VOCATIONAL REHABILITATION SERVICES WITHIN THE DIVISION
26 OF VOCATIONAL REHABILITATION IN THE DEPARTMENT AT THE END OF THE
27 TWO STATE FISCAL YEARS PRECEDING THE REPORT; AND

28 (e) THE ACTUAL EXPENDITURES OF THE DIVISION OF VOCATIONAL
29 REHABILITATION IN THE DEPARTMENT FOR EACH OF THE TWO STATE FISCAL
30 YEARS PRECEDING THE REPORT, INCLUDING THE AMOUNT OF FEDERAL,
31 STATE, AND LOCAL DOLLARS EXPENDED FOR EACH STATE FISCAL YEAR."
