1 Amend the Health and Human Services Committee Report, dated March  
2 5, 2025, page 1, strike lines 2 through 6 and substitute:

3 "Page 10 of the reengrossed bill, strike lines 2 through 4 and substitute  
4 "board of health based on recommendations of the advisory committee on  
5 immunization practices of the centers for disease control and prevention  
6 in the federal department of health and human services IN RULES ADOPTED  
7 IN ACCORDANCE WITH SECTION 25-4-904 (1); or".".

8 Page 1 of the committee report, strike line 21 and substitute "RULES  
9 ADOPTED IN ACCORDANCE WITH SECTION 25-4-904 (1);".".

10 Page 1 of the committee report, strike line 23 and substitute:

11 ""SECTION 14. In Colorado Revised Statutes, **amend** 25-4-904  
12 as follows:

13 **25-4-904. Rules - immunization rules - rule-making authority**  
14 **of state board of health.** (1) (a) The state board of health shall establish  
15 rules ~~and regulations~~ for administering this part 9. ~~Such~~ IN ORDER TO  
16 PREVENT THE TRANSMISSION OF COMMUNICABLE DISEASES AND THE  
17 EFFECTS OF SERIOUS DISEASES, THE STATE BOARD OF HEALTH rules ~~and~~  
18 ~~regulations~~ shall:

19 (I) Establish ~~which~~ THE immunizations ~~shall be~~ THAT ARE required  
20 and the manner and frequency of their administration, TAKING INTO  
21 CONSIDERATION RECOMMENDATIONS OF THE ADVISORY COMMITTEE ON  
22 IMMUNIZATION PRACTICES OF THE CENTERS FOR DISEASE CONTROL AND  
23 PREVENTION IN THE FEDERAL DEPARTMENT OF HEALTH AND HUMAN  
24 SERVICES AND, AS APPROPRIATE, RECOMMENDATIONS OF THE AMERICAN  
25 ACADEMY OF PEDIATRICS, THE AMERICAN ACADEMY OF FAMILY  
26 PHYSICIANS, THE AMERICAN COLLEGE OF OBSTETRICIANS AND  
27 GYNECOLOGISTS, AND THE AMERICAN COLLEGE OF PHYSICIANS; and ~~shall~~

28 (II) Conform to recognized standard medical practices.

29 (b) ~~Such~~ THE rules ~~and regulations~~ may also require the reporting  
30 of statistical information and names of noncompliers by the schools.

31 (c) The department of public health and environment shall  
32 administer and enforce the immunization requirements.

33 (2) All rule-making authority granted to the state board of health  
34 under this article 4 is granted on the condition that the general assembly  
35 reserves the power to delete or rescind any rule of the board. All rules  
36 ~~promulgated~~ ADOPTED pursuant to this ~~subsection (2)~~ SECTION are subject  
37 to section 24-4-103.

6   APPROPRIATE, BY THE AMERICAN ACADEMY OF PEDIATRICS, THE  
7   AMERICAN ACADEMY OF FAMILY PHYSICIANS, THE AMERICAN COLLEGE  
8   OF OBSTETRICIANS AND GYNECOLOGISTS, AND THE AMERICAN COLLEGE  
9   OF PHYSICIANS. The state".
