13 (12)(k)(I) OF THIS SECTION MAY PROHIBIT DELIVERY OF RETAIL
14 MARIJUANA AND RETAIL MARIJUANA PRODUCTS FROM A RETAIL
15 MARIJUANA STORE THAT IS OUTSIDE A MUNICIPALITY'S, COUNTY'S, CITY'S,
16 OR CITY AND COUNTY'S JURISDICTIONAL BOUNDARIES TO AN ADDRESS
17 WITHIN ITS JURISDICTIONAL BOUNDARIES.".

18 Page 17, strike lines 2 through 7 and substitute:

22 CENTER THAT IS OUTSIDE A MUNICIPALITY'S, COUNTY'S, CITY'S, OR CITY
23 AND COUNTY'S JURISDICTIONAL BOUNDARIES TO AN ADDRESS WITHIN ITS
24 JURISDICTIONAL BOUNDARIES.".

25 Page 19, line 10, strike "CENTER" and substitute "STORE".

26 Page 20, strike lines 17 through 22 and substitute:

27 "(II) AN ORDINANCE ADOPTED PURSUANT TO SUBSECTION (5)(i)(I)
28 OF THIS SECTION MAY PROHIBIT DELIVERY OF RETAIL MARIJUANA AND
29 RETAIL MARIJUANA PRODUCTS FROM A RETAIL MARIJUANA STORE THAT IS
30 OUTSIDE A MUNICIPALITY'S, COUNTY'S, CITY'S, OR CITY AND COUNTY'S
31 JURISDICTIONAL BOUNDARIES TO AN ADDRESS WITHIN ITS JURISDICTIONAL
32 BOUNDARIES.".
