

HOUSE COMMITTEE OF REFERENCE AMENDMENT  
Committee on Finance.

HB19-1234 be amended as follows:

1 Amend the Business Affairs & Labor Committee Report, dated April 2,  
2 2019, page 7, line 27, after "PATIENT" insert "OR PARENT OR GUARDIAN".

3 Page 7, line 33, strike "GUARDIAN;" and substitute "GUARDIAN AT THE  
4 ADDRESS PROVIDED IN THE ORDER;".

5 Page 7, line 35, after "OR" insert "PARENT OR GUARDIAN OR".

6 Page 8, strike lines 6 through 19 and substitute:

7        "(g) (I) AT THE TIME OF THE ORDER, THE MEDICAL MARIJUANA  
8 CENTER SHALL REQUIRE THE PATIENT OR PARENT OR GUARDIAN TO  
9 PROVIDE INFORMATION NECESSARY TO VERIFY THE PATIENT IS QUALIFIED  
10 TO PURCHASE AND RECEIVE A DELIVERY OF MEDICAL MARIJUANA AND  
11 MEDICAL MARIJUANA-INFUSED PRODUCTS PURSUANT TO THIS SECTION.  
12 THE PROVIDED INFORMATION MUST, AT A MINIMUM, INCLUDE THE  
13 FOLLOWING:

14        (A) THE PATIENT'S NAME AND DATE OF BIRTH;

15        (B) THE REGISTRATION NUMBER REFLECTED ON THE PATIENT'S  
16 REGISTRY IDENTIFICATION CARD ISSUED PURSUANT TO SECTION  
17 25-1.5-106;

18        (C) IF THE PATIENT IS UNDER EIGHTEEN YEARS OF AGE, THE NAME  
19 AND DATE OF BIRTH OF THE PARENT OR GUARDIAN DESIGNATED AS THE  
20 PATIENT'S PRIMARY CAREGIVER, AND IF APPLICABLE, THE REGISTRATION  
21 NUMBER OF THE PRIMARY CAREGIVER;

22        (D) THE ADDRESS OF THE RESIDENCE WHERE THE ORDER WILL BE  
23 DELIVERED; AND

24        (E) ANY OTHER INFORMATION REQUIRED BY STATE LICENSING  
25 AUTHORITY RULE.

26        (II) PRIOR TO TRANSFERRING POSSESSION OF THE ORDER TO A  
27 PATIENT OR A PARENT OR GUARDIAN, THE PERSON DELIVERING THE ORDER  
28 SHALL INSPECT THE PATIENT'S OR PARENT'S OR GUARDIAN'S  
29 IDENTIFICATION AND REGISTRY IDENTIFICATION CARD ISSUED PURSUANT  
30 TO SECTION 25-1.5-106, VERIFY THE POSSESSION OF A VALID REGISTRY  
31 IDENTIFICATION CARD ISSUED PURSUANT TO SECTION 25-1.5-106, AND  
32 VERIFY THAT THE INFORMATION PROVIDED AT THE TIME OF THE ORDER  
33 MATCH THE NAME AND AGE ON THE PATIENT'S OR PARENT'S OR  
34 GUARDIAN'S IDENTIFICATION.".

35 Page 12, strike lines 16 through 24 and substitute:

36        "(g) (I) AT THE TIME OF THE ORDER, THE RETAIL MARIJUANA  
37 STORE SHALL REQUIRE THE INDIVIDUAL TO PROVIDE INFORMATION

1 NECESSARY TO VERIFY THE INDIVIDUAL IS AT LEAST TWENTY-ONE YEARS  
2 OF AGE. THE PROVIDED INFORMATION MUST, AT A MINIMUM, INCLUDE THE  
3 FOLLOWING:

4 (A) THE PATIENT'S NAME AND DATE OF BIRTH;  
5 (B) THE ADDRESS OF THE RESIDENCE WHERE THE ORDER WILL BE  
6 DELIVERED; AND  
7 (C) ANY OTHER INFORMATION REQUIRED BY STATE LICENSING  
8 AUTHORITY RULE.

9 (II) PRIOR TO TRANSFERRING POSSESSION OF THE ORDER TO AN  
10 INDIVIDUAL, THE PERSON DELIVERING THE ORDER SHALL INSPECT THE  
11 INDIVIDUAL'S IDENTIFICATION AND VERIFY THAT THE INFORMATION  
12 PROVIDED AT THE TIME OF THE ORDER MATCH THE NAME AND AGE ON THE  
13 INDIVIDUAL'S IDENTIFICATION.".

14 Page 15, strike lines 19 through 21 and substitute:

15 "(III) DELIVER ONLY TO A PATIENT OR PARENT OR GUARDIAN AT  
16 THE ADDRESS PROVIDED IN THE ORDER;".

17 Page 15, strike lines 34 through 41 and substitute:

18 (e) PRIOR TO TRANSFERRING POSSESSION OF THE ORDER TO A  
19 PATIENT OR A PARENT OR GUARDIAN, THE PERSON DELIVERING THE ORDER  
20 SHALL INSPECT THE PATIENT'S OR PARENT'S OR GUARDIAN'S  
21 IDENTIFICATION AND REGISTRY IDENTIFICATION CARD ISSUED PURSUANT  
22 TO SECTION 25-1.5-106, VERIFY THE POSSESSION OF A VALID REGISTRY  
23 IDENTIFICATION CARD ISSUED PURSUANT TO SECTION 25-1.5-106, AND  
24 VERIFY THAT THE INFORMATION PROVIDED AT THE TIME OF THE ORDER  
25 MATCH THE NAME AND AGE ON THE PATIENT'S OR PARENT'S OR  
26 GUARDIAN'S IDENTIFICATION.".

27 Page 19, strike lines 12 through 16 and substitute:

28 (e) PRIOR TO TRANSFERRING POSSESSION OF THE ORDER TO AN  
29 INDIVIDUAL, THE PERSON DELIVERING THE ORDER SHALL INSPECT THE  
30 INDIVIDUAL'S IDENTIFICATION AND VERIFY THAT THE INFORMATION  
31 PROVIDED AT THE TIME OF THE ORDER MATCH THE NAME AND AGE ON THE  
32 INDIVIDUAL'S IDENTIFICATION.".

33 After "DELIVER" insert "ONLY" on: **Page 12**, line 6; **Page 15**, line 24; and  
34 **Page 19**, line 2.
