1 Amend the Health and Human Services Committee Report, dated
2 February 4, 2025, page 1, after line 18 insert:

3 "Page 14 of the bill, line 24, strike "(1)" and substitute "(1), (2), and (4)".

4 Page 15 of the bill, line 7, strike "Any".

5 Page 15 of the bill, strike lines 8 through 14 and substitute "A SCHOOL
6 OFFICIAL MAY ACCEPT any immunization record ~~provided by a licensed~~
7 ~~physician, registered nurse, or public health official may be accepted by~~
8 ~~the school official as certification~~ AS PROOF of immunization. ~~if the~~
9 ~~information is transferred to the official certificate of immunization and~~
10 ~~verified by the school official.~~

11 (2) (a) (I) EXCEPT AS PROVIDED IN SUBSECTION (2)(a)(II) OF THIS
12 SECTION, each school shall maintain on file an official certificate of
13 immunization for every student enrolled IN THE SCHOOL.

14 (II) IN LIEU OF AN OFFICIAL CERTIFICATE OF IMMUNIZATION, A
15 LICENSED CHILDREN'S RESIDENTIAL CAMP MAY MAINTAIN ON FILE AN
16 OUT-OF-STATE IMMUNIZATION RECORD FOR AN OUT-OF-STATE CAMPER
17 ATTENDING THE RESIDENTIAL CAMP.

18 (b) (I) WHEN A STUDENT WITHDRAWS, TRANSFERS, IS PROMOTED,
19 OR OTHERWISE LEAVES A SCHOOL, THE SCHOOL SHALL:

20 (A) RETURN the OFFICIAL certificate ~~shall be returned~~ OF
21 IMMUNIZATION to the parent or guardian OF A STUDENT or, IF A STUDENT
22 IS EMANCIPATED OR EIGHTEEN YEARS OF AGE OR OLDER, TO the
23 ~~emancipated student; or student eighteen years of age or older when a~~
24 ~~student withdraws, transfers, is promoted, or otherwise leaves the school,~~
25 ~~or the school shall~~

26 (B) Transfer the OFFICIAL certificate OF IMMUNIZATION with the
27 student's school record to the new school.

28 (II) Upon a college or university student's request, the COLLEGE OR
29 UNIVERSITY SHALL FORWARD THE official certificate of immunization
30 ~~shall be forwarded~~ as specified by the student.

31 (4) All students enrolled in any school in Colorado on and after
32 August 15, 1979, shall furnish the required OFFICIAL certificate of
33 immunization or shall be suspended or expelled from school. Students
34 enrolling in school in Colorado for the first time on and after July 1, 1978,
35 shall provide a AN OFFICIAL certificate of immunization or shall be
36 excluded from school except as provided in section 25-4-903."."
