

SENATE FLOOR AMENDMENT

Second Reading

BY SENATOR Smallwood

1 Amend reengrossed bill, page 7, after line 13 insert:

2 "(V) IN ADDITION TO THE INFORMATION A CARRIER IS REQUIRED TO
3 POST ON ITS PUBLIC-FACING WEBSITE PURSUANT TO SUBSECTION (2)(c)(IV)
4 OF THIS SECTION, A CARRIER SHALL ALSO POST, IN THE MANNER REQUIRED
5 BY SUBSECTION (2)(c)(IV) OF THIS SECTION, AND REPORT TO THE DIVISION
6 THE FOLLOWING INFORMATION:

7 (A) THE PER-MEMBER, PER-MONTH COST IMPACT THAT
8 IMPLEMENTING A PROGRAM ADOPTED BY THE CARRIER OR PBM PURSUANT
9 TO SECTION 10-16-124.5 (5.5) HAS HAD ON THE MONTHLY PREMIUMS PAID
10 BY CONSUMERS; AND

11 (B) THE NUMBER AND TYPES OF PRESCRIPTION DRUGS THAT THE
12 CARRIER OR PBM REMOVED FROM ITS DRUG FORMULARY DUE TO THE
13 INABILITY TO MANAGE PATIENT SAFETY AND PRESCRIPTION DRUG COSTS
14 DUE TO THE IMPLEMENTATION OF A PROGRAM ADOPTED BY THE CARRIER
15 OR PBM PURSUANT TO SECTION 10-16-124.5 (5.5) THAT REDUCES OR
16 ELIMINATES PRIOR AUTHORIZATION REQUIREMENTS FOR PRESCRIPTION
17 DRUGS.

18 (VI) THE DIVISION SHALL CREATE A PUBLIC-FACING AND EASILY
19 SEARCHABLE WEBSITE THAT PROVIDES:

20 (A) A CONSOLIDATED LIST OF LINKS TO EACH CARRIER'S
21 PUBLIC-FACING WEBSITE ON WHICH THE INFORMATION REQUIRED BY THIS
22 SUBSECTION (2)(c) AND SECTION 10-16-124.5 (3.5) IS POSTED; AND

23 (B) THE PER-MEMBER, PER-MONTH COST IMPACT THAT A PROGRAM
24 ADOPTED BY A CARRIER OR PBM PURSUANT TO SECTION 10-16-124.5 (5.5)
25 HAS HAD ON THE MONTHLY PREMIUMS PAID BY CONSUMERS."

26 Renumber succeeding subparagraph accordingly.

27 Strike "(2)(c)(I) AND (2)(c)(IV)" and substitute "(2)(c)(I), (2)(c)(IV), AND
28 (2)(c)(V)" on: **Page 7**, lines 15 and 17.
