

SB19-054 be amended as follows:

1 Strike the State, Veterans, and Military Affairs Committee Report, dated  
2 March 13, 2019, and substitute:

3 "Amend printed bill, strike everything below the enacting clause and  
4 substitute:

5       **"SECTION 1.** In Colorado Revised Statutes, 42-6-102, **amend**  
6 (11.5)(b) introductory portion and (11.5)(b)(III); and **add** (6.3) and (20.5)  
7 as follows:

8       **42-6-102. Definitions.** As used in this part 1, unless the context  
9 otherwise requires:

10       (6.3) "HISTORICAL MILITARY VEHICLE" MEANS A VEHICLE OF ANY  
11 SIZE OR WEIGHT THAT IS VALUED FOR HISTORICAL PURPOSES, THAT WAS  
12 MANUFACTURED FOR USE BY ANY NATION'S ARMED FORCES, AND THAT IS  
13 MAINTAINED IN A CONDITION THAT REPRESENTS ITS MILITARY DESIGN AND  
14 MARKINGS.

15       (11.5) (b) "Off-highway vehicle" includes vehicles commonly  
16 known as all-terrain vehicles, **and** snowmobiles, **AND** SURPLUS MILITARY  
17 VEHICLES but does not include:

18       (III) HISTORICAL military vehicles;

19       (20.5) "SURPLUS MILITARY VEHICLE" MEANS A SELF-PROPELLED  
20 VEHICLE THAT WAS:

21       (I) PURCHASED FOR NONMILITARY USE; AND

22       (II) BUILT FOR THE UNITED STATES ARMED FORCES.

23       **SECTION 2.** In Colorado Revised Statutes, 33-14.5-101, **amend**  
24 the introductory portion and (3) introductory portion; and **repeal** (3)(c) as  
25 follows:

26       **33-14.5-101. Definitions.** As used in this ~~article~~ ARTICLE 14.5,  
27 unless the context otherwise requires:

28       (3) "Off-highway vehicle" means any self-propelled vehicle ~~which~~  
29 ~~THAT~~ is designed to travel on wheels or tracks in contact with the ground,  
30 ~~which~~ is designed primarily for use off of the public highways, and ~~which~~  
31 ~~is~~ generally and commonly used to transport persons for recreational  
32 purposes. "OFF-HIGHWAY VEHICLE" INCLUDES SURPLUS MILITARY  
33 VEHICLES AS DEFINED IN SECTION 42-6-102. "Off-highway vehicle" does  
34 not include the following:

35       (c) ~~Military vehicles;~~

36       **SECTION 3. Safety clause.** The general assembly hereby finds,  
37 determines, and declares that this act is necessary for the immediate  
38 preservation of the public peace, health, and safety.".

1 Page 1, line 101, strike "**DEMILITARIZED MOTOR**" and substitute  
2 "**SURPLUS MILITARY**".".
