

HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Appropriations.

HB22-1012 be amended as follows:

1 Strike the Energy and Environment Committee Report, dated February  
2 17, 2022, and substitute:

3 "Amend printed bill, strike everything below the enacting clause and  
4 substitute:

5 "SECTION 1. In Colorado Revised Statutes, 23-31-313, **amend**  
6 (10)(a)(I); and **add** (9.5) as follows:

7 **23-31-313. Healthy forests - vibrant communities - funds**  
8 **created - repeal. (9.5) Carbon accounting framework.** (a) ON AND  
9 AFTER SEPTEMBER 1, 2022, THE STATE FOREST SERVICE SHALL DEVELOP  
10 A PUBLICLY ACCESSIBLE STATEWIDE CARBON ACCOUNTING FRAMEWORK  
11 THAT YIELDS CARBON STOCK AND FLUX ESTIMATES FOR:

12 (I) ECOSYSTEMS BY COUNTY AND FOREST COVER TYPE; AND

13 (II) WOOD PRODUCTS.

14 (b) THE STATE FOREST SERVICE SHALL ALSO DEVELOP A FOREST  
15 CARBON CO-BENEFIT FRAMEWORK FOR PROJECT-LEVEL FOREST  
16 MANAGEMENT PRACTICES, INCLUDING WILDFIRE MITIGATION. THE STATE  
17 FOREST SERVICE SHALL USE THIS FRAMEWORK TO TRAIN PRACTITIONERS  
18 IN ADAPTIVE MANAGEMENT PRACTICES TO BE INCORPORATED INTO  
19 CURRENT FOREST MANAGEMENT PRACTICES, INCLUDING WILDFIRE  
20 MITIGATION. THE STATE FOREST SERVICE SHALL PROVIDE TECHNICAL  
21 EXPERTISE TO ASSIST INDUSTRY AND LANDOWNERS WITH CARBON  
22 INVENTORIES AND MONITORING.

23 (c) AS USED IN THIS SUBSECTION (9.5), UNLESS THE CONTEXT  
24 OTHERWISE REQUIRES:

25 (I) "CARBON ACCOUNTING FRAMEWORK" MEANS A MODEL THAT  
26 USES DATA FROM THE FOREST INVENTORY AND ANALYSIS PROGRAM OF  
27 THE UNITED STATES DEPARTMENT OF AGRICULTURE'S FOREST SERVICE TO  
28 DEVELOP TABULAR DATA OF CARBON FLUX AND STOCK ESTIMATES FOR  
29 ALL FOREST TYPES AND WOOD PRODUCTS IN THE STATE OF COLORADO.

30 (II) "FOREST CARBON CO-BENEFIT FRAMEWORK" MEANS A  
31 FRAMEWORK THAT LINKS GOALS, STRATEGIES, AND APPROACHES IN THE  
32 2020 COLORADO FOREST ACTION PLAN TO FOREST MANAGEMENT AND  
33 WILDFIRE RISK MITIGATION PRACTICES THAT SERVE TO IMPROVE CARBON  
34 SEQUESTRATION.

35 (10) **Healthy forests and vibrant communities fund.**

36 (a) (I) There is hereby created in the state treasury the healthy forests and  
37 vibrant communities fund. The fund consists of all money that may be  
38 appropriated thereto by the general assembly and all private and public

1 money received through gifts, grants, reimbursements, or donations that  
2 are transmitted to the state treasurer and credited to the fund. All interest  
3 earned from the investment of money in the fund is credited to the fund.  
4 The money in the fund is hereby continuously appropriated for the  
5 purposes specified in this subsection (10) SECTION and remains available  
6 until expended. Any money not expended at the end of the fiscal year  
7 shall remain in the fund and shall not be transferred to or revert to the  
8 general fund.

9 **SECTION 2. Appropriation.** For the 2022-23 state fiscal year,  
10 \$95,407 is appropriated to the healthy forests and vibrant communities  
11 fund created in section 23-1-313 (10)(a)(I), C.R.S. This appropriation is  
12 from the general fund. The department of higher education is responsible  
13 for the accounting related to this appropriation.

14 **SECTION 3. Act subject to petition - effective date.** This act  
15 takes effect at 12:01 a.m. on the day following the expiration of the  
16 ninety-day period after final adjournment of the general assembly; except  
17 that, if a referendum petition is filed pursuant to section 1 (3) of article V  
18 of the state constitution against this act or an item, section, or part of this  
19 act within such period, then the act, item, section, or part will not take  
20 effect unless approved by the people at the general election to be held in  
21 November 2022 and, in such case, will take effect on the date of the  
22 official declaration of the vote thereon by the governor."."

23 Page 1, strike lines 101 through 103 and substitute "**CONCERNING**  
24 **HEALTHY FORESTS, AND, IN CONNECTION THEREWITH, MAKING AN**  
25 **APPROPRIATION.**".
