## SENATE FLOOR AMENDMENT

- 1    Amend the Education Committee Report, dated April 3, 2019, page 1,  
2    strike line 20 and substitute "COMPLETION OF A GATEWAY COURSE, AS  
3    DEFINED IN SECTION 23-1-113 (1)(b.5), APPLIES TOWARD EARNING".
- 4    Page 2, line 23, strike "THOSE" and substitute "QUALIFIED".
- 5    Page 2, line 27, after the period add "THE LOCAL EDUCATION PROVIDER  
6    MAY DETERMINE THE MANNER IN WHICH CONCURRENT ENROLLMENT  
7    OPPORTUNITIES ARE PROVIDED.".
- 8    Page 2, line 41, after the period add "A LOCAL EDUCATION PROVIDER MAY  
9    EXPAND ITS ABILITY TO PROVIDE ACCESS TO CONCURRENT ENROLLMENT  
10   OPPORTUNITIES AS PROVIDED IN SECTION 23-1-109 (6).".
- 11   Page 4, line 6, strike "student and the" and substitute "QUALIFIED student  
12   and the QUALIFIED".
- 13   Page 4, line 11, before "STUDENT" insert "QUALIFIED".
- 14   Page 4, line 20, before "student" insert "QUALIFIED".
- 15   Page 4, line 21, before "student," insert "QUALIFIED".
- 16   Page 5, line 9, before "STUDENT'S" insert "QUALIFIED".
- 17   Page 5, line 10, before "STUDENT'S" insert "QUALIFIED".
- 18   Page 5, line 23, before "STUDENTS" insert "QUALIFIED".
- 19   Page 5, after line 33, insert:  
20        **"SECTION 4.** In Colorado Revised Statutes, 22-35-110, **amend**  
21        (1) as follows:  
22            **22-35-110. Exclusions.** (1) The provisions of this ~~article~~ ARTICLE  
23        shall not apply to any course that is offered as part of a program of  
24        off-campus instruction established pursuant to ~~section 23-1-109, C.R.S.~~  
25        SECTION 23-1-109 (1) TO (5).
- 26        **SECTION 5.** In Colorado Revised Statutes, 22-35-111, **add** (2)  
27        as follows:  
28            **22-35-111. Rules.** (2) BY JULY 1, 2020, THE STATE BOARD SHALL  
29        ADOPT RULES TO SPECIFY THE NUMBER OF POSTSECONDARY CREDITS IN

1     WHICH A QUALIFIED STUDENT MUST BE CONCURRENTLY ENROLLED TO  
2     QUALIFY FOR FULL-TIME MEMBERSHIP FOR PURPOSES OF THE "PUBLIC  
3     SCHOOL FINANCE ACT OF 1994", ARTICLE 54 OF THIS TITLE 22.".

4     Renumber succeeding sections accordingly.

5     Page 8, line 10, before "STUDENTS," insert "QUALIFIED".

6     Page 8, line 23, before "STUDENTS" insert "QUALIFIED".

7     Page 8, line 39, strike "ENROLLMENT;" and substitute "ENROLLMENT,  
8     INCLUDING NEED THAT MAY ARISE AS A RESULT OF A  
9     HIGHER-THAN-ANTICIPATED PARTICIPATION RATE;".

10    Page 9, line 5, before "STUDENTS" insert "QUALIFIED".

11    Page 9, line 23, strike "OR" and substitute "OF".

12    Page 10, line 12, before "STUDENTS" insert "QUALIFIED".
