

SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Agriculture & Natural Resources.

SB25-038 be amended as follows:

1 Amend printed bill, page 4, strike lines 1 through 3 and substitute  
2 "SECTIONS 33-3-107 TO 33-3-110 AND SITE ASSESSMENTS CONDUCTED BY  
3 STATE OFFICIALS AND THIRD PARTIES TO PREVENT FUTURE DEPREDATION  
4 AND ANY PERSONAL OR OTHERWISE IDENTIFYING INFORMATION  
5 ASSOCIATED WITH THE USE OF PROACTIVE NONLETHAL  
6 PREDATOR-LIVESTOCK CONFLICT MINIMIZATION MEASURES IS  
7 CONFIDENTIAL AND".

8 Page 4, after line 5 insert:

9        "(3) NOTHING IN THIS SECTION PROHIBITS THE DISCLOSURE OF  
10 NONIDENTIFYING INFORMATION REGARDING COUNTY-LEVEL DATA  
11 HIGHLIGHTING THE NUMBER OR DOLLAR AMOUNT OF CLAIMS MADE TO THE  
12 DIVISION, THE NUMBER OF CLAIMS MADE TO THE DIVISION THAT WERE  
13 SETTLED AND THE MONETARY AMOUNTS OF THOSE SETTLEMENTS, THE  
14 NUMBER OF CLAIMS MADE TO THE DIVISION THAT ARE PENDING AT THE  
15 TIME OF A REQUEST FOR DISCLOSURE, AND THE NUMBER OF CLAIMS MADE  
16 TO THE DIVISION THAT WERE DENIED AND THE REASONS FOR DENIAL.

17        (4) NOTWITHSTANDING ANY PROVISION OF THIS SECTION TO THE  
18 CONTRARY, IF A PERSON, OR AN AUTHORIZED DESIGNEE OR  
19 REPRESENTATIVE OF THE PERSON, TAKES ACTIONS OR MAKES STATEMENTS  
20 THAT LEAD TO THE PERSON'S PERSONAL INFORMATION BECOMING  
21 PUBLICLY KNOWN, THE PERSONAL INFORMATION IS NOT CONFIDENTIAL  
22 AND IS SUBJECT TO DISCLOSURE PURSUANT TO THE "COLORADO OPEN  
23 RECORDS ACT", PART 2 OF ARTICLE 72 OF TITLE 24.

24        (5) A PERSON SHALL NOT BRING OR MAINTAIN A PRIVATE ACTION,  
25 AT LAW OR IN EQUITY, CHALLENGING THE DIVISION'S DETERMINATION  
26 THAT A PERSON, OR AN AUTHORIZED DESIGNEE OR REPRESENTATIVE OF  
27 THE PERSON, HAS TAKEN ACTIONS OR MADE STATEMENTS THAT LED TO  
28 THE PERSON'S PERSONAL INFORMATION BECOMING PUBLICLY KNOWN.".

29        Renumber succeeding subsection accordingly.

30        Page 4, lines 6 and 7, strike "NOTWITHSTANDING ANY PROVISION OF THIS  
31 SECTION TO THE CONTRARY, ANY" and substitute "ANY".

32        Strike "CLAIMANT'S" and substitute "PERSON'S" on: **Page 3**, lines 17 and  
33 25; and **Page 4**, line 9.

34        Strike "CLAIMANT" and substitute "PERSON" on: **Page 3**, lines 25 and 26;  
35 and **Page 4**, lines 7 and 8.
