

SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Appropriations.

HB22-1278 be amended as follows:

1 Amend reengrossed bill, page 263, line 19, strike "\$638,518" and  
2 substitute "\$638,608".

3 Page 263, line 21, strike "\$48,021" and substitute "\$48,111".

4 Page 264, after line 7 insert:

5       **"SECTION 244. Appropriation - adjustments to 2022 long  
6 bill.** (1) To implement this act, appropriations made in the annual general  
7 appropriation act for the 2022-23 state fiscal year to the department of  
8 human services are adjusted as follows:

9           (a) The cash funds appropriation from the marijuana tax cash fund  
10 created in section 39-28.8-501 (1), C.R.S., for health, life, and dental is  
11 decreased by \$12,282;

12           (b) The cash funds appropriation from the marijuana tax cash fund  
13 created in section 39-28.8-501 (1), C.R.S., for short-term disability is  
14 decreased by \$91;

15           (c) The cash funds appropriation from the marijuana tax cash fund  
16 created in section 39-28.8-501 (1), C.R.S., for S.B. 04-257 amortization  
17 equalization disbursement is decreased by \$2,877; and

18           (d) The cash funds appropriation from the marijuana tax cash fund  
19 created in section 39-28.8-501 (1), C.R.S., for S.B. 06-235 supplemental  
20 amortization equalization disbursement is decreased by \$2,877.

21           (2) For the 2022-23 state fiscal year, \$18,127 is appropriated to  
22 the department of public health and environment. This appropriation is  
23 from the marijuana tax cash fund created in section 39-28.8-501 (1),  
24 C.R.S. To implement this act, the department may use this appropriation  
25 as follows:

26           (a) \$12,282 for health, life, and dental;

27           (b) \$91 for short-term disability;

28           (c) \$2,877 for S.B. 04-257 amortization equalization  
29 disbursement; and

30           (d) \$2,877 for S.B. 06-235 supplemental amortization equalization  
31 disbursement.".

32       Renumber succeeding sections accordingly.

33       Page 265, after line 18 insert:

34       **"SECTION 249. Appropriation - adjustments to 2022 long**

1       **bill.** (1) To implement this act, appropriations made in the annual general  
2        appropriation act for the 2022-23 state fiscal year to the legislative  
3        department are adjusted as follows:

4           (a) The general fund appropriation for use by the legislative  
5        council is decreased by \$20,736, and the related FTE is decreased by 0.3  
6        FTE;

7           (b) The general fund appropriation for use by the office of  
8        legislative legal services is decreased by \$17,095, and the related FTE is  
9        decreased by 0.2 FTE; and

10           (c) The general fund appropriation for use by the general assembly  
11        is decreased by \$14,117.".
