HB22-1278 be amended as follows:

- 1 Amend printed bill, page 18, line 4, after "FROM" insert "THE ADVISORY
- 2 COUNCIL CREATED PURSUANT TO SECTION 27-50-701, THE REGIONAL
- 3 SUBCOMMITTEES CREATED PURSUANT TO SECTION 27-50-703, AND".
- 4 Page 56, strike lines 22 through 24 and substitute "THE PURPOSE OF
- 5 MAKING RECOMMENDATIONS TO THE COMMISSIONER AND THE STATE
- 6 BOARD OF HUMAN SERVICES TO IMPROVE THE BEHAVIORAL HEALTH
- 7 SYSTEM FOR CHILDREN, YOUTH, AND ADULTS THROUGHOUT COLORADO."
- 8 Page 57, strike lines 6 and 7 and substitute:
- 9 "(b) ESTABLISHING WORKING GROUPS TO SUPPORT".
- 10 Page 57, line 18, strike "COMMISSIONER." and substitute "COMMISSIONER
- 11 FOR THREE-YEAR TERMS; EXCEPT THAT SOME OF THE INITIAL TERMS MAY
- 12 BE FOR TWO YEARS."
- 13 Page 58, strike lines 5 and 6 and substitute:
- 14 "(VII) PERSONS WITH EXPERTISE IN THE BEHAVIORAL HEALTH
- 15 NEEDS OF CHILDREN AND YOUTH."
- 16 Page 58, line 11, after "CRIMINAL" insert "OR JUVENILE".
- 17 Page 58, strike line 13 and substitute:
- 18 "**27-50-703. Advisory council - regional subcommittees -**
- 19 **subcommittees - working groups.** (1) THE BHA SHALL CREATE ONE
- 20 REGIONAL SUBCOMMITTEE OF THE ADVISORY COUNCIL FOR EACH
- 21 BEHAVIORAL HEALTH ADMINISTRATIVE SERVICES ORGANIZATION REGION
- 22 ESTABLISHED PURSUANT TO SECTION 27-50-401. REGIONAL
- 23 SUBCOMMITTEE MEMBERS ARE APPOINTED BY THE COMMISSIONER FOR
- 24 THREE-YEAR TERMS; EXCEPT THAT INITIAL TERMS MAY BE FOR TWO
- 25 YEARS. EACH REGIONAL SUBCOMMITTEE CONSISTS OF FIVE MEMBERS.
- 26 EXCEPT AS PROVIDED IN THIS SECTION, MEMBERS OF THE REGIONAL
- 27 SUBCOMMITTEES NEED NOT BE MEMBERS OF THE ADVISORY COUNCIL
- 28 APPOINTED PURSUANT TO SECTION 27-50-702. MEMBERSHIP OF THE
- 29 REGIONAL SUBCOMMITTEES MUST INCLUDE:
- 30 (a) AT LEAST ONE INDIVIDUAL WHO IS ALSO A MEMBER OF THE
- 31 ADVISORY COUNCIL APPOINTED PURSUANT TO SECTION 27-50-702;
- 32 (b) AT LEAST ONE INDIVIDUAL WHO REPRESENTS A BEHAVIORAL
- 33 HEALTH SAFETY NET PROVIDER THAT OPERATES WITHIN THE REGION; AND
- 34 (c) A COUNTY COMMISSIONER OF A COUNTY SITUATED WITHIN THE
- 35 REGION."
- 36 Renumber succeeding subsections accordingly.
- 37 Page 59, line 1, strike "REGIONS OR".
