

HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Appropriations.

HB23-1272 be amended as follows:

- 1 Amend printed bill, page 67, after line 19 insert:
 - 2 "(f) "QUALIFIED PURCHASER" MEANS A PERSON WHO IS A RESIDENT
 - 3 OF THE STATE AND WHO HAS NOT PREVIOUSLY PURCHASED A QUALIFIED
 - 4 ELECTRIC BICYCLE THAT WAS DISCOUNTED BY A QUALIFIED RETAILER
 - 5 CLAIMING A TAX CREDIT ALLOWED BY THIS SECTION FOR THE RETAIL SALE
 - 6 IN THE SAME INCOME TAX YEAR."
- 7 Reletter succeeding paragraphs accordingly.
- 8 Page 68, line 8, strike "EIGHT" and substitute "FIVE".
- 9 Page 68, strike lines 10 and 11 and substitute "DURING THE INCOME TAX
- 10 YEAR TO A QUALIFIED PURCHASER".
- 11 Page 68, strike lines 13 and 14 and substitute "PURSUANT TO THIS
- 12 SECTION, THE QUALIFIED RETAILER SHALL PROVIDE TO THE QUALIFIED
- 13 PURCHASER".
- 14 Page 68, line 17, strike "SEVEN HUNDRED" and substitute "FOUR HUNDRED
- 15 FIFTY".
- 16 Page 68, line 19, strike "PURCHASER; AND" and substitute "QUALIFIED
- 17 PURCHASER".
- 18 Page 68, strike lines 20 through 22.
- 19 Page 68, line 27, strike "ONE".
- 20 Page 69, line 1, strike "HUNDRED" and substitute "FIFTY".
- 21 Page 69, line 19, after "(a)" insert "(I)".
- 22 Page 70, after line 3 insert:
 - 23 "(II) THE OFFICE SHALL DEVELOP A PROCESS FOR PURCHASERS TO
 - 24 REGISTER AS QUALIFIED PURCHASERS, THROUGH THE OFFICE AND PRIOR TO
 - 25 PURCHASING A QUALIFIED ELECTRIC BICYCLE FROM A QUALIFIED
 - 26 RETAILER, BY AFFIRMING THE PURCHASER'S RESIDENCY AND THAT THE
 - 27 PURCHASER HAS NOT PREVIOUSLY PURCHASED A QUALIFIED ELECTRIC
 - 28 BICYCLE THAT WAS DISCOUNTED PURSUANT TO THIS SECTION IN THE SAME
 - 29 INCOME TAX YEAR. THE PROCESS MUST ALLOW FOR A QUALIFIED RETAILER
 - 30 TO ACCESS QUALIFIED PURCHASER INFORMATION IN ORDER TO CONFIRM A

1 PURCHASER IS A QUALIFIED PURCHASER."
