1 Amend printed bill, page 29, before line 20 insert:

2 **"SECTION 25.** In Colorado Revised Statutes, **add 44-3-409.5 as**
3 **follows:**

4 **44-3-409.5. Retail to retail sales - local permit required -**
5 **substance use disorder funding.** (1) EFFECTIVE JANUARY 1, 2025, A
6 PERSON LICENSED UNDER SECTION 44-3-409 MAY SELL AND DELIVER
7 ALCOHOL BEVERAGES TO ANOTHER RETAILER LICENSED UNDER SECTION
8 44-3-409.5 AND SECTIONS 44-3-411, 44-3-413, 44-3-414, 44-3-416,
9 44-3-417, 44-3-418, 44-3-419, 44-3-420, 44-3-422, 44-3-426, AND
10 44-3-428 IF AUTHORIZED BY THE LOCAL LICENSING AUTHORITY.

11 (2) A LOCAL LICENSING AUTHORITY SHALL ESTABLISH A PERMIT
12 FOR THE SALE AND DELIVERY OF ALCOHOL BEVERAGES BY A RETAIL
13 LIQUOR STORE TO RETAILERS, SETTING FEES FOR THE PROCESSING AND
14 APPROVAL OF A RETAILER SALE AND DELIVERY PERMIT APPLICATION, AND
15 ANY OTHER MATTER NECESSARY FOR THE SAFE AND EFFECTIVE
16 IMPLEMENTATION OF THIS SECTION.

17 (3) THE LOCAL LICENSING AUTHORITY SHALL TRANSMIT FIVE
18 PERCENT OF THE PERMIT FEES COLLECTED PURSUANT TO SUBSECTION
19 (6)(b) OF THIS SECTION AND TRANSMIT THE MONEY TO THE STATE
20 TREASURER WHO SHALL TRANSFER THE MONEY TO THE BEHAVIORAL
21 HEALTH ADMINISTRATION FOR THE PURPOSE OF THE BUILDING SUBSTANCE
22 USE DISORDER TREATMENT CAPACITY IN UNDERSERVED COMMUNITIES
23 GRANT PROGRAM, CREATED IN SECTION 27-80-120.

24 (4) BEFORE GRANTING A PERMIT PURSUANT TO THIS SECTION, THE
25 LOCAL LICENSING AUTHORITY SHALL CONSIDER THE REASONABLE
26 REQUIREMENTS OF THE NEIGHBORHOOD; THE DESIRES OF THE ADULT
27 INHABITANTS, AS EVIDENCED BY PETITIONS, REMONSTRANCES, OR
28 OTHERWISE; AND ALL OTHER REASONABLE RESTRICTIONS THAT ARE OR
29 MAY BE PLACED UPON THE NEIGHBORHOOD BY THE LOCAL LICENSING
30 AUTHORITY.".
