SB23-020 be amended as follows:

- 1 Amend the Health and Human Services Committee Report, dated March  
2 16, 2023, page 1, line 1, strike ""(1)(b)(III) and"" and substitute  
3 ""(1)(b)(III), (4.5), and"".
- 4 Page 1 of the report, line 15, strike "ANY" and substitute "EXCEPT AS  
5 OTHERWISE PROVIDED IN SUBSECTION (4.5) OF THIS SECTION, ANY".
- 6 Page 2 of the report, line 5, strike "REQUEST.". and substitute "REQUEST  
7 OR, BEFORE MARCH 1, 2024, FOR A PHYSICIAN WHO IS NOT YET  
8 REGISTERED TO USE AND USING THE ELECTRONIC DEATH REGISTRATION  
9 SYSTEM USED BY THE DEPARTMENT OF PUBLIC HEALTH AND ENVIRONMENT  
10 AND THE STATE REGISTRAR PURSUANT TO SUBSECTION (1)(b)(I) OF THIS  
11 SECTION, SEVENTY-TWO HOURS AFTER RECEIVING NOTICE THAT A  
12 MEDICAL CERTIFICATION FOR A DEATH CERTIFICATE MUST BE  
13 COMPLETED.".
- 14 Page 2 of the report, lines 7 and 8, strike "COMPLETE, SIGN, AND RETURN"  
15 and substitute "COMPLETE A MEDICAL CERTIFICATION FOR".
- 16 Page 2 of the report, line 12, strike ""THE" and substitute ""EXCEPT AS  
17 OTHERWISE PROVIDED IN SUBSECTION (4.5) OF THIS SECTION, THE".
- 18 Page 2 of the report, line 14, after "CERTIFICATION" insert "FOR A DEATH  
19 CERTIFICATE".
- 20 Page 2 of the report, line 24, after "CERTIFICATION" insert "FOR A DEATH  
21 CERTIFICATE".
- 22 Page 2 of the report, after line 17 insert:  
23 "Page 4 of the bill, after line 4 insert:  
24       "(4.5) THE DEPARTMENT OF PUBLIC HEALTH AND ENVIRONMENT  
25       SHALL ENSURE THAT ALL PHYSICIANS ARE REGISTERED TO USE THE  
26       ELECTRONIC DEATH REGISTRATION SYSTEM CREATED AND USED PURSUANT  
27       TO SUBSECTION (1)(b)(I) OF THIS SECTION ON OR BEFORE MARCH 1, 2024.  
28       A PHYSICIAN SHALL USE THE SYSTEM FOR ALL MEDICAL CERTIFICATIONS  
29       FOR DEATH CERTIFICATES REQUIRED BY SUBSECTION (4) OF THIS SECTION  
30       IMMEDIATELY UPON BEING REGISTERED BUT IS NOT REQUIRED TO DO SO  
31       BEFORE BEING REGISTERED."".
- 32 Page 2 of the report, line 21, strike ""A" and substitute ""EXCEPT AS  
33 OTHERWISE PROVIDED IN SUBSECTION (4.5) OF THIS SECTION, A".
