

HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Appropriations.

HB24-1075 be amended as follows:

1 Amend printed bill, page 3, strike lines 6 and 7 and substitute:

2 "(a) "ANALYSIS COLLABORATIVE" MEANS THE STATEWIDE
3 HEALTH-CARE ANALYSIS COLLABORATIVE CREATED PURSUANT TO".

4 Page 8, line 3, strike "BY OCTOBER 1, 2025," and substitute "ON OR
5 BEFORE DECEMBER 31, 2025,".

6 Page 8, line 6, strike "INSURANCE" and substitute "HUMAN SERVICES".

7 Page 8, line 9, after "(6)" insert "(a)".

8 Page 8, after line 12 insert:

9 "(b) THE COLORADO SCHOOL OF PUBLIC HEALTH SHALL SUBMIT AN
10 APPLICATION TO THE ALL-PAYER HEALTH CLAIMS DATABASE SCHOLARSHIP
11 GRANT PROGRAM, ESTABLISHED IN SECTION 25.5-1-204.5, TO ACQUIRE
12 FUNDING TO COVER ANY DATA OR SOFTWARE COSTS THAT MAY BE
13 INCURRED BY THE COLORADO SCHOOL OF PUBLIC HEALTH IN CONDUCTING
14 THE ANALYSIS REQUIRED PURSUANT TO SUBSECTION (4) OF THIS SECTION.".

15 Page 8, strike lines 19 and 20 and substitute, "COLLABORATIVE, REFERRED
16 TO IN THIS SECTION AS THE "ANALYSIS COLLABORATIVE", FOR THE
17 PURPOSE OF ADVISING THE COLORADO SCHOOL OF".

18 Page 9, strike lines 4 and 5 and substitute:

19 "(3)(a) ON OR BEFORE AUGUST 1, 2024, THE EXECUTIVE DIRECTOR
20 OF THE STATE DEPARTMENT SHALL INVITE THE FOLLOWING
21 REPRESENTATIVES TO PARTICIPATE IN THE ANALYSIS COLLABORATIVE:".

22 Page 10, strike lines 11 through 13 and substitute:

23 "(b) IN INVITING REPRESENTATIVES TO PARTICIPATE IN THE
24 ANALYSIS COLLABORATIVE PURSUANT TO SUBSECTION (3)(a) OF THIS
25 SECTION, THE EXECUTIVE DIRECTOR SHALL ENSURE THAT THE INVITEES:".

26 Page 10, line 15, strike "APPOINTEES"" and substitute "INVITEES"".

27 Page 10, strike lines 24 through 26.

- 1 Reletter succeeding paragraph accordingly.
- 2 Page 11, strike lines 1 and 2 and substitute "EXECUTIVE DIRECTOR MAY
3 INVITE A NEW REPRESENTATIVE TO FILL THE VACANCY.".
- 4 Page 11, strike lines 12 through 14.
- 5 Reletter succeeding paragraphs accordingly.
- 6 Page 11, strike lines 16 and 17 and substitute "BEFORE OCTOBER 1, 2025,
7 AND THE EXECUTIVE DIRECTOR OF THE STATE DEPARTMENT, OR THE
8 EXECUTIVE DIRECTOR'S DESIGNEE SERVING ON THE ANALYSIS
9 COLLABORATIVE, MAY CONVENE ADDITIONAL MEETINGS OF THE ANALYSIS
10 COLLABORATIVE AS DETERMINED BY CONSULTING WITH THE MEMBERS OF
11 THE ANALYSIS COLLABORATIVE AND THE SCHOOL OF PUBLIC HEALTH.".
- 12 Page 11, after line 22 insert:
 - 13 "(d) ALL MEETINGS OF THE ANALYSIS COLLABORATIVE SHALL BE
14 HELD VIRTUALLY AND ALLOW FOR ATTENDANCE AND PARTICIPATION BY
15 MEMBERS OF THE ANALYSIS COLLABORATIVE AND MEMBERS OF THE
16 PUBLIC VIRTUALLY.
 - 17 "(e) THE ANALYSIS COLLABORATIVE MAY HOLD MEETINGS WITHOUT
18 A QUORUM OF THE MEMBERS PRESENT.".
- 19 Page 12, line 1, strike "APPOINTED" and substitute "INVITED".
- 20 Page 12, after line 9 insert:
 - 21 "**SECTION 3.** In Colorado Revised Statutes, 23-18-308, **add**
22 (1)(m) as follows:
23 **23-18-308. Fee-for-service contracts - grants to local district**
24 **colleges - limited purpose - repeal.** (1) Subject to available
25 appropriations, the department shall enter into fee-for-service contracts
26 for the following purposes:
27 (m) THE COLORADO SCHOOL OF PUBLIC HEALTH'S ANALYSIS OF
28 MODEL LEGISLATION RELATED TO A STATEWIDE UNIVERSAL HEALTH-CARE
29 SYSTEM CONDUCTED PURSUANT TO SECTION 23-20-146.".
 - 30 Renumber succeeding section accordingly.
 - 31 Strike "ADVISORY TASK FORCE" and substitute "ANALYSIS
32 COLLABORATIVE" on: **Page 8**, line 23; **Page 9**, line 3; **Page 10**, line 27;

1 **Page 11**, lines 8, 11, 15, 18, 19, 23, and 27; and **Page 12**, lines 1, 4, 6,
2 and 7.

3 Page 1, line 103, strike "**ADVISORY TASK FORCE**" and substitute
4 "**ANALYSIS COLLABORATIVE**".
