HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Finance.

HB20-1204 be amended as follows:

- 1 Amend printed bill, page 2, line 11, strike "RETURN." and substitute  
2 "RETURN OR PURSUANT TO SUBSECTION (4)(m) OF THIS SECTION."
- 3 Page 2, lines 15 and 16, strike "CODE THAT PROVIDES" and substitute  
4 "CODE, THAT HAS A PRIMARY OBJECTIVE OF PROVIDING".
- 5 Page 3, line 12, after "ACCOUNTANT." insert "THE CERTIFIED PUBLIC  
6 ACCOUNTANT SHALL EITHER ATTEST THAT THE CONTRIBUTIONS WERE  
7 USED IN COMPLIANCE WITH THIS SUBSECTION (4)(z) OR COMPUTE THE  
8 AMOUNT OF CONTRIBUTIONS THAT WERE NOT USED IN COMPLIANCE WITH  
9 THIS SUBSECTION (4)(z)."
- 10 Page 3, line 17, before "BY" insert "THE DEPARTMENT OF EDUCATION  
11 SHALL PUBLISH ON ITS WEBSITE A LIST OF ORGANIZATIONS THAT SATISFY  
12 THE DEFINITION OF ELIGIBLE SCHOLARSHIP GRANTING ORGANIZATION AS  
13 DEFINED IN THIS SUBSECTION (4)(z)."
- 14 Page 3, line 21, after "(4)(z)." add "THE DEPARTMENT OF EDUCATION  
15 SHALL ALSO SUBMIT TO THE DEPARTMENT A COPY OF ANY AUDIT THAT  
16 FOUND NONCOMPLIANCE WITH THIS SUBSECTION (4)(z)."
- 17 Page 4, lines 9 and 10, strike "CODE THAT PROVIDES" and substitute  
18 "CODE, THAT HAS A PRIMARY OBJECTIVE OF PROVIDING".
- 19 Page 4, line 25, after "ACCOUNTANT." insert "THE CERTIFIED PUBLIC  
20 ACCOUNTANT SHALL EITHER ATTEST THAT THE CONTRIBUTIONS WERE  
21 USED IN COMPLIANCE WITH THIS SUBSECTION (3)(p) OR COMPUTE THE  
22 AMOUNT OF CONTRIBUTIONS THAT WERE NOT USED IN COMPLIANCE WITH  
23 THIS SUBSECTION (3)(p)."
- 24 Page 5, line 3, before "BY" insert "THE DEPARTMENT OF EDUCATION  
25 SHALL PUBLISH ON ITS WEBSITE A LIST OF ORGANIZATIONS THAT SATISFY  
26 THE DEFINITION OF ELIGIBLE SCHOLARSHIP GRANTING ORGANIZATION AS  
27 DEFINED IN THIS SUBSECTION (3)(p)."
- 28 Page 5, line 7, after "(3)(p)." add "THE DEPARTMENT OF EDUCATION  
29 SHALL ALSO SUBMIT TO THE DEPARTMENT A COPY OF ANY AUDIT THAT  
30 FOUND NONCOMPLIANCE WITH THIS SUBSECTION (3)(p)."
- 31 Strike "USES" and substitute "INTENDS TO USE" on: **Page 2**, line 18; and  
32 **Page 4**, line 12.
