

## SENATE FLOOR AMENDMENT

Second Reading

1 Amend reengrossed bill, page 2, line 12, strike "COMMUNICATIONS" and  
2 substitute "COMMUNICATION".

3 Page 3, line 18, strike "COMMUNICATIONS" and substitute  
4 "COMMUNICATION".

5 Page 7, line 25, strike "(11)," and substitute "(9),".

6 Page 8, line 9, strike "IMPOSING" and substitute "BEGINNING JANUARY 1,  
7 2026, IMPOSING".

8 Page 8, line 15, strike "ONCE PER YEAR." and substitute "ON JULY 1, 2026,  
9 AND ON EACH JULY 1 THEREAFTER. THE ENTERPRISE SHALL NOTIFY THE  
10 DEPARTMENT OF REVENUE OF ANY CHANGE MADE TO THE AMOUNT OF THE  
11 CHARGE NO LATER THAN MAY 15 OF THE YEAR PRECEDING THE YEAR IN  
12 WHICH THE AMOUNT CHANGE WILL BECOME EFFECTIVE.".

13 Page 23, strike line 7 and substitute:

14 "SECTION 14. In Colorado Revised Statutes, 29-11-102.7,  
15 amend (2)(a); and add (6) as follows:

16 29-11-102.7. Imposition of telecommunications relay service  
17 surcharge on prepaid wireless - rules - definitions - repeal.  
18 (2) (a) FOR RETAIL TRANSACTIONS MADE PRIOR TO JANUARY 1, 2026, a  
19 prepaid wireless TRS charge of one-tenth of one percent of the price of  
20 the retail transaction is hereby imposed on each retail transaction.

21 (6) THIS SECTION IS REPEALED, EFFECTIVE JULY 1, 2028.".

22 Page 28, line 24, strike "A" and substitute "ON AND AFTER JANUARY 1,  
23 2026, EVERY".

24 Page 30, line 17, after "PENALTIES" insert "AND INTEREST".

25 Page 30, line 23, after "(c)" insert "THE EXECUTIVE DIRECTOR OF THE  
26 DEPARTMENT SHALL COLLECT, ADMINISTER, AND ENFORCE THE PREPAID  
27 TELEPHONE DISABILITY ACCESS CHARGE PURSUANT TO ARTICLE 21 OF  
28 TITLE 39.".

29 Page 37, after line 4 insert:

30 "SECTION 26. In Colorado Revised Statutes, 39-21-102, add (9)

1 as follows:  
2 **39-21-102. Scope.** (9) THIS ARTICLE 21 APPLIES TO THE FEE  
3 IMPOSED PURSUANT TO SECTION 40-17-104, BUT ONLY TO THE EXTENT  
4 THAT THIS ARTICLE 21 IS NOT INCONSISTENT WITH SECTION 40-17-104."

5 Renumber succeeding sections accordingly.

6 Page 42, after line 7 insert:

7 **"SECTION 33. Effective date.** (1) Except as otherwise provided  
8 in this section, this act takes effect upon passage.  
9 (2) Sections 39-21-102, 29-2-201, 29-2-202, and 39-21-119.5,  
10 Colorado Revised Statutes, as amended in sections 26, 27, 28, and 29 of  
11 this act, respectively, take effect January 1, 2026."

12 Amend the Business, Labor, and Technology Committee Report, dated  
13 March 27, 2025, page 3, strike lines 20 and 21 and substitute:

14 "Page 18 of the reengrossed bill, line 27, strike "with, or as proposed by,"  
15 and substitute "with ~~or as proposed by,~~".
