

HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Business Affairs & Labor.

HB22-1314 be amended as follows:

- 1 Amend printed bill, page 11, after line 14 insert:
2 "SECTION 8. In Colorado Revised Statutes, 40-10.1-403, **amend**
3 (5)(a); and **add** (4)(d)(I)(C) and (5)(c) as follows:
4 **40-10.1-403. Towing task force - creation - rules - repeal.**
5 (4) (d) (I) By December 1 of each year, the commission shall make a
6 report to the house of representatives transportation and local government
7 committee, the house of representatives business affairs and labor
8 committee, the senate business, labor, and technology committee, and the
9 senate transportation and energy committee, or any successor committees.
10 The report must:
11 (C) INCLUDE THE ANALYSIS REQUIRED IN SUBSECTION (5)(C) OF
12 THIS SECTION.
13 (5) The task force has the following duties and powers:
14 (a) To make comprehensive recommendations to the commission
15 about the maximum rates that may be charged for the recovery, towing,
16 and storage of a vehicle that has been towed without the owner's consent.
17 The task force shall make comprehensive recommendations to the
18 commission about the maximum rates after July 1, 2022, but no later than
19 ~~September 1, 2022~~ November 1, 2022.
20 (c) TO ANALYZE AND MAKE RECOMMENDATIONS TO THE
21 COMMISSION ABOUT NONCONSENSUAL TOWING RATES CHARGED TO THE
22 PUBLIC. IN ANALYZING NONCONSENSUAL RATES, THE TASK FORCE SHALL
23 TAKE INTO ACCOUNT CURRENT CONSENSUAL TOWING MARKET RATES AND
24 THEIR RELATIONSHIP TO NONCONSENSUAL TOWING RATES."
25 Renumber succeeding sections accordingly.
26 Page 11, lines 16 and 17, strike "and 40-10.1-411" and substitute
27 "40-10.1-411, and 40-10.1-412".
28 Page 11, strike lines 19 through 27 and substitute "**and lienholders -**
29 **rules. (1) Towing fees. (a) TOWING CARRIERS SHALL PROMINENTLY**
30 **DISPLAY AT THEIR PLACE OF BUSINESS AND ON ANY WEBSITE OF THE**
31 **TOWING CARRIER THE CURRENT MAXIMUM RATES PERMITTED BY RULE OF**
32 **THE COMMISSION FOR EACH TOW SERVICE PROVIDED BY THE TOWING**
33 **CARRIER. THE SIGN MUST INCLUDE THE FOLLOWING STATEMENT: "THE**
34 **MAXIMUM PERMITTED RATE IS BASED UPON RULES OF THE PUBLIC**
35 **UTILITIES COMMISSION, AND IF THERE ARE CONCERNS OR QUESTIONS**
36 **ABOUT THESE RATES OR THE TOWING CARRIER, THEN CALL THE PUBLIC**
37 **UTILITIES COMMISSION CONSUMER AFFAIRS HOTLINE AT 303-894-2070."**

- 1 Page 12, strike lines 1 through 13.
- 2 Reletter succeeding paragraphs accordingly.
- 3 Page 12, line 21, strike "(1)(c)" and substitute "(1)(b)".
- 4 Page 18, line 1, strike "(1)(c)" and substitute "(1)(b)".
- 5 Page 21, line 3, strike "(1)(c)" and substitute "(1)(b)".
- 6 Page 27, after line 5 insert:
 - 7 **"40-10.1-411. Nonconsensual towing rules.** UPON MAKING A
 - 8 FINDING THAT A NONCONSENSUAL TOWING PRACTICE HARMS THE PUBLIC
 - 9 INTEREST, THE COMMISSION MAY PROMULGATE RULES, AS NECESSARY, TO
 - 10 STOP OR CHANGE THE NONCONSENSUAL TOWING PRACTICE THAT HARMS
 - 11 THE PUBLIC INTEREST."
- 12 Renumber succeeding C.R.S. section accordingly.
