Second Reading

1 Amend printed bill, page 8, line 4, after "(2)(c); insert "HOSPITALITY
2 LOCATIONS;".

3 Page 8, after line 17 insert:

4 "(III) PRINTED PAPER USED TO DISTRIBUTE FINANCIAL
5 STATEMENTS, BILLING STATEMENTS, MEDICAL DOCUMENTS, OR OTHER
6 VITAL DOCUMENTS REQUIRED TO BE PROVIDED IN PAPER FORM BY
7 APPLICABLE CONSUMER PROTECTIONS LAWS OR OTHER STATE OR FEDERAL
8 LAWS;".

9 Renumber succeeding sub-paragraphs accordingly.

10 Page 9, line 9, strike "AS A TOXIC OR HAZARDOUS MATERIAL".

11 Page 16, line 13, before "COSTS" insert "APPLICABLE".

12 Page 33, line 12, strike "SIXTY" and substitute "NINETY".

13 Page 33, line 21, strike "THIRTY" and substitute "FORTY-FIVE".

14 Page 42, line 2, strike "DUES" and substitute "DUES, RECYCLING RATES,
15 COLLECTION RATES, POSTCONSUMER-RECYCLED-CONTENT RATES, AND
16 ANY OTHER MATERIALS NECESSARY FOR THE EXECUTIVE DIRECTOR TO
17 DETERMINE COMPLIANCE WITH THIS PART 6".

18 Page 42, after line 6 insert:

19 "(c) THE ORGANIZATION, ANY ADDITIONAL PRODUCER
20 RESPONSIBILITY ORGANIZATION, AND ANY PERSON ADMINISTERING A PLAN
21 APPROVED BY THE EXECUTIVE DIRECTOR PURSUANT TO THIS PART 6 SHALL
22 MAINTAIN ALL DOCUMENTS AND RECORDS NECESSARY FOR THE EXECUTIVE
23 DIRECTOR TO DETERMINE COMPLIANCE WITH THIS PART 6 AND SUBMIT ANY
24 SUCH DOCUMENTS AND RECORDS TO THE EXECUTIVE DIRECTOR UPON A
25 REQUEST BY THE EXECUTIVE DIRECTOR PURSUANT TO SUBSECTION (1)(b)
26 OF THIS SECTION.".

27 Page 51, after line 1 insert:

28 **"SECTION 3. Severability.** If any provision of this act or the
29 application thereof to any person or circumstance is held invalid, such
30 invalidity does not affect other provisions or applications of the act that
31 can be given effect without the invalid provision or application, and to
32 this end the provisions of this act are declared to be severable.".
