18 (III) DESCRIBE HOW THE PRODUCER WILL REIMBURSE SERVICE
19 PROVIDERS THAT PROVIDE RECYCLING SERVICES FOR THE COVERED
20 MATERIALS COVERED BY THE INDIVIDUAL PROGRAM PLAN PROPOSAL; AND

21 (IV) DESCRIBE ANY ALTERNATIVE COLLECTION PROGRAMS RUN BY
22 THE PRODUCER AND ITS RECYCLING RATES.

23 (b) THE ADVISORY BOARD SHALL REVIEW AND MAKE
24 RECOMMENDATIONS ON, AND THE EXECUTIVE DIRECTOR SHALL APPROVE
25 OR REJECT, ANY INDIVIDUAL PROGRAM PLAN PROPOSALS IN ACCORDANCE
26 WITH THE PROCEDURES SET FORTH IN SUBSECTION (5) OF THIS SECTION.
27 AFTER THE EXECUTIVE DIRECTOR APPROVES THE INDIVIDUAL PROGRAM
