

SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Business, Labor, & Technology.

SB24-048 be amended as follows:

1 Amend printed bill, page 15, strike lines 24 through 27.

2 Strike page 16.

3 Page 17, strike lines 1 through 19 and substitute:

4       **"SECTION 5.** In Colorado Revised Statutes, **add** 44-3-108 as  
5 follows:

6       **44-3-108. Substance use disorders - recovery - retail liquor**  
7 **sales - stakeholder group - rules - repeal.** (1) NO LATER THAN JULY 1,  
8 2025, IN ORDER TO ASSIST INDIVIDUALS WHO ARE RECOVERING FROM  
9 SUBSTANCE USE DISORDERS, THE LIQUOR ENFORCEMENT DIVISION SHALL  
10 ADOPT RULES RELATED TO THE LOCATION OF ALCOHOL BEVERAGE  
11 DISPLAYS.

12       (2) THE LIQUOR ENFORCEMENT DIVISION SHALL CONVENE A  
13 STAKEHOLDER GROUP OF THE FOLLOWING MEMBERS TO DEVELOP THE  
14 RULES REQUIRED IN SUBSECTION (1) OF THIS SECTION:

15       (a) FOUR INDIVIDUALS REPRESENTING RECOVERY PROVIDERS, OF  
16 WHOM TWO INDIVIDUALS MUST REPRESENT A RECOVERY PROVIDER IN A  
17 RURAL OR FRONTIER AREA AND TWO INDIVIDUALS MUST REPRESENT A  
18 RECOVERY PROVIDER IN A METRO OR URBAN AREA;

19       (b) TWO INDIVIDUALS REPRESENTING A RECOVERY RESIDENCE, AS  
20 DEFINED IN SECTION 27-80-129 (1)(b);

21       (c) THREE INDIVIDUALS, EACH REPRESENTING A CONVENIENCE  
22 STORE LICENSED UNDER THIS ARTICLE 3 OR ARTICLE 4 OF THIS TITLE 44 TO  
23 SELL ALCOHOL BEVERAGES; AND

24       (d) THREE INDIVIDUALS, EACH REPRESENTING A GROCERY STORE  
25 LICENSED UNDER THIS ARTICLE 3 OR ARTICLE 4 OF THIS TITLE 44 TO SELL  
26 ALCOHOL BEVERAGES.

27       (3) THE LIQUOR ENFORCEMENT DIVISION SHALL PROVIDE NOTICE  
28 OF STAKEHOLDER MEETINGS ON ITS WEBSITE AND HOLD STAKEHOLDER  
29 MEETINGS OPEN TO THE PUBLIC.

30       (4) THIS SECTION IS REPEALED, EFFECTIVE SEPTEMBER 1, 2026.".
