

HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Education.

HB22-1066 be amended as follows:

1 Amend printed bill, strike everything below the enacting clause and  
2 substitute the following:

3 "SECTION 1. In Colorado Revised Statutes, **add** 22-1-134 as  
4 follows:

5 **22-1-134. Educational materials - educator professional**  
6 **development - transparency - definitions.** (1) AS USED IN THIS SECTION,  
7 UNLESS THE CONTEXT OTHERWISE REQUIRES:

8 (a) "EDUCATIONAL MATERIALS" MEANS ALL WRITTEN MATERIALS  
9 AND ELECTRONIC RESOURCES THAT AN EDUCATOR USES IN TEACHING IN  
10 PRESCHOOL, KINDERGARTEN, OR GRADES ONE THROUGH FIVE OR IN  
11 TEACHING A COURSE IN GRADES SIX THROUGH TWELVE, INCLUDING BUT  
12 NOT LIMITED TO TEXTBOOKS, SUPPLEMENTAL WORKSHEETS OR TEXTS,  
13 ASSIGNED OR RECOMMENDED READING MATERIALS, ELECTRONIC OR  
14 DIGITAL MATERIALS OR OTHER RESOURCES, AND COURSE SYLLABUSES.

15 (b) "EDUCATOR" MEANS A CLASSROOM TEACHER, A PERSON  
16 EMPLOYED BY THE LOCAL EDUCATION PROVIDER TO PROVIDE  
17 PROFESSIONAL SERVICES TO STUDENTS IN DIRECT SUPPORT OF THE  
18 EDUCATION INSTRUCTIONAL PROGRAM, OR A SCHOOL ADMINISTRATOR.

19 (c) "LOCAL EDUCATION PROVIDER" MEANS A SCHOOL DISTRICT  
20 CREATED PURSUANT TO ARTICLE 30 OF THIS TITLE 22, A BOARD OF  
21 COOPERATIVE SERVICES CREATED PURSUANT TO ARTICLE 5 OF THIS TITLE  
22 22 THAT OPERATES A PUBLIC SCHOOL, A CHARTER SCHOOL AUTHORIZED  
23 PURSUANT TO PART 1 OF ARTICLE 30.5 OF THIS TITLE 22, OR AN INSTITUTE  
24 CHARTER SCHOOL AUTHORIZED PURSUANT TO PART 5 OF ARTICLE 30.5 OF  
25 THIS TITLE 22.

26 (d) "PARENT" MEANS A BIOLOGICAL PARENT, ADOPTIVE PARENT,  
27 LEGAL GUARDIAN, OR ANY OTHER PERSON HAVING LEGAL CUSTODY OF A  
28 CHILD.

29 (2)(a) BEGINNING IN THE 2022-23 SCHOOL YEAR AND CONTINUING  
30 IN SCHOOL YEARS THEREAFTER, THE PARENT OF A STUDENT WHO IS  
31 ENROLLED BY A LOCAL EDUCATION PROVIDER MAY SUBMIT A WRITTEN  
32 REQUEST TO THE LOCAL EDUCATION PROVIDER TO REVIEW ANY OF THE  
33 EDUCATIONAL MATERIALS OR OTHER MATERIALS DESCRIBED IN  
34 SUBSECTION (2)(b) OF THIS SECTION OR TO OBTAIN ANY OF THE  
35 INFORMATION SPECIFIED IN SUBSECTION (2)(c) OF THIS SECTION. WITHIN  
36 SEVEN CALENDAR DAYS AFTER RECEIVING THE REQUEST, THE LOCAL  
37 EDUCATION PROVIDER SHALL RESPOND TO THE REQUEST BY PROVIDING A  
38 COPY OF THE REQUESTED EDUCATIONAL OR OTHER MATERIALS OR  
39 PROVIDING THE INFORMATION. THE LOCAL EDUCATION PROVIDER MAY  
40 CHOOSE TO ALLOW THE PARENT ACCESS TO REVIEW THE REQUESTED  
41 EDUCATIONAL OR OTHER MATERIALS AT A SCHOOL SITE RATHER THAN

1 PROVIDE A COPY OF THE MATERIALS. THE LOCAL EDUCATION PROVIDER  
2 SHALL NOT IMPOSE A NONDISCLOSURE REQUIREMENT OF ANY KIND ON A  
3 PARENT WHO RECEIVES A COPY OF OR REVIEWS EDUCATIONAL OR OTHER  
4 MATERIALS OR WHO RECEIVES INFORMATION PURSUANT TO THIS SECTION.  
5 (b) A LOCAL EDUCATION PROVIDER SHALL PROVIDE ACCESS TO THE  
6 FOLLOWING MATERIALS UPON REQUEST AS PROVIDED IN SUBSECTION (2)(a)  
7 OF THIS SECTION:  
8 (I) THE EDUCATIONAL MATERIALS THAT THE LOCAL EDUCATION  
9 PROVIDER USES IN DELIVERING EDUCATIONAL SERVICES TO THE STUDENTS  
10 THE LOCAL EDUCATION PROVIDER ENROLLS, INCLUDING:  
11 (A) THE EDUCATIONAL MATERIALS USED IN PRESCHOOL THROUGH  
12 FIFTH GRADE FOR EACH GRADE LEVEL AND SUBJECT; AND  
13 (B) THE EDUCATIONAL MATERIALS USED FOR EACH COURSE  
14 OFFERED IN GRADES SIX THROUGH TWELVE FOR EACH GRADE LEVEL AND  
15 COURSE;  
16 (II) EACH SURVEY, NONACADEMIC ASSESSMENT, ANALYSIS, AND  
17 EVALUATION DISTRIBUTED TO THE STUDENTS THE LOCAL EDUCATION  
18 PROVIDER ENROLLS; AND  
19 (III) THE LOCAL EDUCATION PROVIDER'S POLICY CONCERNING THE  
20 TEACHING OF CONTROVERSIAL ISSUES, IF THE LOCAL EDUCATION PROVIDER  
21 ADOPTS A POLICY PURSUANT TO SUBSECTION (3) OF THIS SECTION.  
22 (c) A LOCAL EDUCATION PROVIDER SHALL PROVIDE THE  
23 FOLLOWING INFORMATION UPON REQUEST AS PROVIDED IN SUBSECTION  
24 (2)(a) OF THIS SECTION:  
25 (I) IDENTIFICATION OF EACH ELECTRONIC DEVICE AND  
26 EDUCATIONAL PROGRAM OR SOFTWARE THAT THE LOCAL EDUCATION  
27 PROVIDER USES THAT COLLECTS BIOMETRIC DATA FROM STUDENTS AND  
28 THE GRADE LEVELS, SUBJECTS, AND COURSES IN WHICH THEY ARE USED;  
29 (II) THE NUMBER OF PROFESSIONAL DEVELOPMENT HOURS OR  
30 COURSE CREDITS THAT EDUCATORS ARE REQUIRED TO COMPLETE AND THE  
31 LENGTH OF TIME DURING WHICH THEY MUST BE COMPLETED;  
32 (III) THE OPTIONS AVAILABLE TO EDUCATORS FOR MEETING THE  
33 PROFESSIONAL DEVELOPMENT REQUIREMENTS AND ANY SPECIFIC COURSES  
34 OR TYPES OF PROFESSIONAL DEVELOPMENT THAT THE LOCAL EDUCATION  
35 PROVIDER REQUIRES EDUCATORS TO COMPLETE OR THAT ARE REQUIRED BY  
36 STATUTE OR RULE;  
37 (IV) THE AVERAGE AMOUNT OF MONEY THE LOCAL EDUCATION  
38 PROVIDER ANNUALLY SPENDS IN PROVIDING PROFESSIONAL DEVELOPMENT  
39 TO THE EDUCATORS IT EMPLOYS; AND  
40 (V) THE PROFESSIONAL DEVELOPMENT ACTIVITIES THE LOCAL  
41 EDUCATION PROVIDER PROVIDES TO THE EDUCATORS IT EMPLOYS, WHICH  
42 ARE COMPLETED BY THE EDUCATORS TO MEET PROFESSIONAL  
43 DEVELOPMENT REQUIREMENTS FOR EDUCATOR LICENSE RENEWAL,

1 AGGREGATED BY TYPE OF EDUCATOR, FOR THE PRECEDING THREE SCHOOL  
2 YEARS.

3 (3) THE GOVERNING BOARD FOR EACH LOCAL EDUCATION  
4 PROVIDER MAY ADOPT A POLICY CONCERNING THE TEACHING OF  
5 CONTROVERSIAL ISSUES. IF ADOPTED, THE POLICY MUST, AT A MINIMUM,  
6 INCLUDE PROCEDURES BY WHICH A PERSON MAY REPORT A VIOLATION OF  
7 THE POLICY TO THE GOVERNING BOARD FOR THE LOCAL EDUCATION  
8 PROVIDER.

9 **SECTION 2. Safety clause.** The general assembly hereby finds,  
10 determines, and declares that this act is necessary for the immediate  
11 preservation of the public peace, health, or safety."

12 Page 1, strike lines 103 and 104 and substitute "INFORMATION TO THE  
13 PUBLIC."
