

HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on State, Civic, Military, & Veterans Affairs.

HB25-1319 be amended as follows:

- 1 Amend printed bill, page 6, line 25, strike "AT LEAST SEVENTY-FIVE DAYS
- 2 PRIOR TO THE COUNTY COMMISSIONER VACANCY ELECTION," and
- 3 substitute "NO LATER THAN THIRTY DAYS AFTER THEIR PETITION FORMAT
- 4 HAS BEEN APPROVED OR EIGHTY-FIVE DAYS PRIOR TO THE COUNTY
- 5 COMMISSIONER VACANCY ELECTION, WHICHEVER IS SOONER,".

- 6 Page 7, strike line 4 and substitute "ELECTED. PART 9 OF ARTICLE 4 OF
- 7 THIS TITLE 1 APPLIES TO PETITIONS SUBMITTED PURSUANT TO SUBSECTION
- 8 (8) OF THIS SECTION; EXCEPT THAT THE PROVISIONS OF PART 9 OF ARTICLE
- 9 4 OF THIS TITLE 1 THAT CONFLICT WITH THE REQUIREMENTS OR TIMELINE
- 10 DESCRIBED IN THIS SECTION DO NOT APPLY TO PETITIONS SUBMITTED
- 11 PURSUANT TO SUBSECTION (8) OF THIS SECTION. PETITIONS MUST NOT BE
- 12 CIRCULATED AND SIGNATURES MUST NOT BE OBTAINED PRIOR TO THE
- 13 FIRST BUSINESS DAY AFTER THE EFFECTIVE DATE OF THE VACANCY. A
- 14 PETITION MUST NOT BE CIRCULATED UNTIL IT HAS BEEN APPROVED AS
- 15 MEETING THE REQUIREMENTS OF SECTION 1-4-904 AS TO FORM. THE
- 16 COUNTY CLERK AND RECORDER SHALL APPROVE OR DISAPPROVE A
- 17 PETITION AS TO FORM NO LATER THAN THE CLOSE OF THE SECOND
- 18 BUSINESS DAY FOLLOWING SUBMISSION OF THE PROPOSED PETITION.".

- 19 Page 7, strike lines 15 through 18 and substitute "THE VACANCY
- 20 COMMITTEE MEMBER'S SIGNATURE ONLY COUNTS TOWARD THE THIRTY
- 21 PERCENT OF APPLICABLE VACANCY COMMITTEE MEMBER SIGNATURES
- 22 REQUIRED PURSUANT TO SUBSECTION (8)(c)(I) OF THIS SECTION ON THE
- 23 FIRST NOMINATING STATEMENT SUBMITTED THAT CONTAINS THE
- 24 SIGNATURE.".

- 25 Page 8, lines 9 and 10, strike "LATER SIGNATURE DOES NOT COUNT" and
- 26 substitute "SIGNATURE ONLY COUNTS".

- 27 Page 8, strike line 12 and substitute "SECTION ON THE FIRST PETITION
- 28 SUBMITTED THAT CONTAINS THE SIGNATURE.".
