Committee on State, Civic, Military, & Veterans Affairs.

HB25-1319 be amended as follows:

- 1 Amend printed bill, page 9, strike line 26 and substitute "and (8) as  
2 follows:".
- 3 Page 10, strike lines 4 and 5 and substitute ""CANDIDATE" ALSO INCLUDES  
4 A CANDIDATE FOR A COUNTY COMMISSIONER VACANCY ELECTION, AS  
5 DEFINED IN SECTION 1-12-206 (9)".
- 6 Page 10, strike lines 13 through 26.
- 7 Page 11, strike lines 6 through 10 and substitute "ESTABLISHED IN THE  
8 NAME OF A CANDIDATE WHO IS RUNNING FOR A COUNTY COMMISSIONER  
9 VACANCY ELECTION, AS DEFINED IN SECTION 1-12-206 (9), MAY ACCEPT  
10 FROM ANY ONE PERSON THE AGGREGATE CONTRIBUTION LIMIT FOR A  
11 GENERAL ELECTION AS SPECIFIED IN SUBSECTION (1.5) OF".
- 12 Page 11, strike lines 14 through 16 and substitute "CANDIDATE WHO IS  
13 RUNNING FOR A COUNTY COMMISSIONER VACANCY ELECTION, AS DEFINED  
14 IN SECTION 1-12-206 (9), MAY EXPEND CONTRIBUTIONS IN ACCORDANCE".
- 15 Page 11, after line 18 insert:  
16 "SECTION 6. In Colorado Revised Statutes, 1-45-108, **amend**  
17 (2)(a)(I)(C), (2)(a)(I)(D), and (2)(a)(I)(F) as follows:  
18 **1-45-108. Disclosure - definitions - repeal.** (2) (a) (I) Except as  
19 provided in subsections (2)(a)(V), (2.1), (2.5), (2.7), and (6) of this  
20 section, such reports that are required to be filed with the secretary of  
21 state must be filed:  
22 (C) On the first day of each month beginning the sixth full month  
23 before the major election; except that no monthly report shall be required  
24 on the first day of the month in which the major election OR COUNTY  
25 COMMISSIONER VACANCY ELECTION, AS DEFINED IN SECTION 1-12-206(9),  
26 is held;  
27 (D) On the first Monday in September and on each Monday every  
28 two weeks thereafter before the major election OR COUNTY  
29 COMMISSIONER VACANCY ELECTION, AS DEFINED IN SECTION 1-12-206(9);  
30 (F) Fourteen days before and thirty days after a special legislative  
31 election OR COUNTY COMMISSIONER VACANCY ELECTION, AS DEFINED IN  
32 SECTION 1-12-206 (9), held in an off-election year."
- 33 Renumber succeeding section accordingly.
