Second Reading

1 Amend the Public and Behavioral Health and Human Services Committee
2 Report, dated February 7, 2023, page 1, after line 15, insert:

4 "Page 4, line 5, strike "WILL" and substitute "MAY".

5 Page 4, line 13, strike "IF" and substitute "AND TOLD WHETHER".

6 Page 4, strike lines 15 through 27 and substitute "CONCERN.".

7 Page 5, strike lines 1 through 4 and substitute:

8 "(5) A STUDENT MENTAL HEALTH SCREENING MUST BE CONDUCTED
9 ONLY:

10 (a) AFTER A WRITTEN RECOMMENDATION FROM A PARENT OF A
11 STUDENT;

12 (b) AS A RESULT OF A CONSULTATION BETWEEN A PARENT OF A
13 STUDENT AND A TEACHER OR SCHOOL PSYCHOLOGIST WHO RECOMMENDS
14 TO THE PARENT OF A STUDENT THAT A SCREENING BE CONDUCTED FOR THE
15 STUDENT, AFTER WHICH THE PARENT PROVIDES WRITTEN PERMISSION FOR
16 THE SCREENING TO OCCUR; OR

17 (c) AS A RESULT OF A CONSULTATION BETWEEN A PARENT OF A
18 STUDENT AND A LOCAL LAW ENFORCEMENT OFFICIAL WHO RECOMMENDS
19 TO THE PARENT OF A STUDENT THAT A SCREENING BE CONDUCTED, AFTER
20 WHICH THE PARENT OF THE STUDENT PROVIDES WRITTEN PERMISSION FOR
21 THE SCREENING TO OCCUR."".

22 Page 2 of the report, strike lines 11 through 13 and substitute:

23 "Page 6, line 1, strike "WHICH" and substitute "WITHIN TWENTY-FOUR
24 HOURS AFTER THE STUDENT COMPLETES THE MENTAL HEALTH SCREENING
25 WHETHER THE STUDENT NEEDS ADDITIONAL MENTAL HEALTH SERVICES.
26 ONCE THIS DETERMINATION IS MADE, THE SCREENER MUST NOTIFY THE
27 PARENT OF EACH STUDENT THAT IS DETERMINED TO NEED ADDITIONAL
28 MENTAL HEALTH SERVICES AND PROVIDE THE STUDENT AND THE
29 STUDENT'S PARENT WITH INFORMATION ON MENTAL HEALTH RESOURCES
30 AND SERVICES PROVIDED THROUGH iMATTER, INCLUDING HOW TO APPLY
31 FOR SERVICES THROUGH iMATTER.".

32 Page 6, strike line 2.".
