Committee on Judiciary.

HB23-1199 be amended as follows:

- 1 Amend printed bill, page 2, lines 8 and 9, strike "EVIDENCE OBTAINED
- 2 FROM THEIR FORENSIC MEDICAL EVIDENCE EXAMINATIONS." and substitute
- 3 "THEIR SEXUAL ASSAULT EVIDENCE COLLECTION KIT".

- 4 Page 2, line 10, strike "DECEMBER 31, 2024." and substitute "JUNE 30,
- 5 2025".

- 6 Page 2, line 17, strike "EVIDENCE" and substitute "THEIR SEXUAL ASSAULT
- 7 EVIDENCE COLLECTION KIT".

- 8 Page 3, line 2, after "POSSESSION" insert "OF THE VICTIM'S SEXUAL
- 9 ASSAULT EVIDENCE COLLECTION KIT".

- 10 Page 3, line 3, strike "ANALYSIS;" and substitute "ANALYSIS OF THE
- 11 VICTIM'S SEXUAL ASSAULT EVIDENCE COLLECTION KIT;"

- 12 Page 3, strike line 4 and substitute "EARLIEST ANTICIPATED DATE OF
- 13 DESTRUCTION OF THE EVIDENCE OBTAINED FROM THE VICTIM'S FORENSIC
- 14 MEDICAL EVIDENCE EXAMINATION".

- 15 Page 3, line 10, strike "EVIDENCE" and substitute "THE VICTIM'S SEXUAL
- 16 ASSAULT EVIDENCE COLLECTION KIT".

- 17 Page 3, strike line 12 and substitute "EARLIEST ANTICIPATED DATE OF
- 18 DESTRUCTION OF THE EVIDENCE OBTAINED FROM THE VICTIM'S FORENSIC
- 19 MEDICAL EVIDENCE EXAMINATION".

- 20 Page 3, line 15, strike "NAVIGATING THE CRIMINAL JUSTICE SYSTEM;" and
- 21 substitute "FINANCIAL ASSISTANCE AND COMPENSATION PROGRAMS FOR
- 22 VICTIMS OF SEXUAL ASSAULT;"

- 23 Page 3, line 16, strike "INFORMATION;" and substitute "INFORMATION
- 24 CONCERNING VICTIMS OF AN ALLEGED SEXUAL ASSAULT;"

- 25 Strike "FORENSIC MEDICAL EVIDENCE EXAMINATIONS" and substitute
- 26 "SEXUAL ASSAULT EVIDENCE COLLECTION KITS" on: **Page 4**, lines 23, and
- 27 26 and 27; and **Page 5**, lines 1 and 2.
