19 controlling the discretion of the court, ~~shall~~ MUST be accorded weight in
20 making determinations called for by subsection (1) of this section:

21 (o) THE DEFENDANT IS A PREGNANT OR POSTPARTUM DEFENDANT,
22 AS DEFINED IN SECTION 18-1.3-103.7."
