

SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Transportation & Energy.

SB22-016 be amended as follows:

1 Amend printed bill, page 3, line 16, after "(1)," insert "(2) introductory  
2 portion,".

3 Page 3, line 17, strike "(2.3) and".

4 Page 3, lines 19 and 20, strike "which BEFORE FEBRUARY 1, 2025, THE  
5 COMMISSION shall consist" and substitute "which shall consist BEFORE  
6 FEBRUARY 1, 2025, THE COMMISSION CONSISTS".

7 Page 4, line 3, after "OF" insert "ELEVEN".

8 Page 4, strike lines 5 through 27.

9 Strike page 5.

10 Page 6, strike lines 1 and 2 and substitute:

11 "(2) FOR TERMS COMMENCING BEFORE FEBRUARY 1, 2025, one  
12 member of the commission shall be appointed by the governor from each  
13 of the following districts, AND FOR TERMS COMMENCING ON OR AFTER  
14 FEBRUARY 1, 2025, ONE MEMBER SHALL BE ELECTED FROM EACH OF THE  
15 FOLLOWING DISTRICTS:

16 (2.5) (a) AT THE NOVEMBER 2024 GENERAL ELECTION, ALL  
17 ELEVEN MEMBERS OF THE COMMISSION SHALL BE ELECTED FOR TERMS  
18 COMMENCING ON FEBRUARY 1, 2025. THE INITIAL TERMS OF THE MEMBERS  
19 ELECTED FROM THE DISTRICTS DESCRIBED IN SUBSECTIONS (2)(a), (2)(c),  
20 (2)(e), (2)(g), (2)(i), AND (2)(k) OF THIS SECTION ARE FOUR YEARS, AND  
21 THE INITIAL TERMS OF THE MEMBERS ELECTED FROM THE DISTRICTS  
22 DESCRIBED IN SUBSECTIONS (2)(b), (2)(d), (2)(f), (2)(h), AND (2)(j) OF THIS  
23 SECTION ARE TWO YEARS. THEREAFTER, AS TERMS EXPIRE, MEMBERS OF  
24 THE COMMISSION SHALL BE ELECTED AT GENERAL ELECTIONS FOR TERMS  
25 OF FOUR YEARS.

26 (b) THE MEMBERS OF THE COMMISSION SHALL BE NOMINATED AND  
27 ELECTED BY THE REGISTERED ELECTORS OF EACH DISTRICT DESCRIBED IN  
28 SUBSECTION (2) OF THIS SECTION AS SPECIFIED BY LAW.".

29 Page 6, line 3, strike "(e)" and substitute "(c)".
