

## HOUSE FLOOR AMENDMENT

Second Reading

1 Strike the State, Civic, Military, and Veterans Affairs committee report,  
2 dated April 7, 2025, and substitute:  
3 "Amend printed bill, page 3, strike lines 2 through 8.

4 Strike pages 4 through 6 of the bill.

5 Page 7 of the bill, strike lines 1 through 19.

6 Page 7 of the bill, line 21, strike "and (3)(a); and **add** (1.5)".

7 Strike page 8 of the bill and substitute "of this section, the vacancy ~~shall~~  
8 MUST be filled THROUGH A SPECIAL LEGISLATIVE ELECTION HELD IN  
9 ACCORDANCE WITH SECTION 1-11-302 ON THE FIRST SUNDAY THAT FALLS  
10 AT LEAST SIXTY DAYS AFTER THE DATE UPON WHICH THE VACANCY IS  
11 EFFECTIVE. ~~by the appropriate vacancy committee, if any, as provided in~~  
12 ~~section 1-3-103 (1)(d), of the same political party and of the same~~  
13 ~~representative or senatorial district represented by the former member~~  
14 ~~whose seat is vacant. If the member was affiliated with a minor political~~  
15 ~~party, then the vacancy shall be filled by the vacancy committee~~  
16 ~~designated in the constitution or bylaws of the minor political party. If the~~  
17 ~~member was unaffiliated with a political party, then the vacancy shall be~~  
18 ~~filled by the vacancy committee designated on the petition for nomination~~  
19 ~~pursuant to section 1-4-802 (1)(c). The vacancy shall be filled until the~~  
20 ~~next general election after the vacancy occurs, when the vacancy shall be~~  
21 ~~filled by election.~~

22 **SECTION 2.** In Colorado Revised Statutes, 1-11-302, **add** (1.5)  
23 as follows:

24 **1-11-302. Causes of special legislative election.**  
25 (1.5) NOTWITHSTANDING SUBSECTION (1) OF THIS SECTION, THE STATE  
26 SENATE OR THE STATE HOUSE OF REPRESENTATIVES, ACTING BY  
27 RESOLUTION, MAY CALL A SPECIAL LEGISLATIVE ELECTION FOR A STATE  
28 SENATE OR HOUSE OF REPRESENTATIVES DISTRICT IF A VACANCY IN THE  
29 STATE SENATE OR HOUSE OF REPRESENTATIVES OCCURS."

30 Strike pages 9 through 13 of the bill.

31 Page 14 of the bill, strike lines 1 through 24.

32 Page 14 of the bill, line 25, strike "8" and substitute "3".
