

HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Health & Insurance.

HB23-1218 be amended as follows:

1 Amend printed bill, page 3, line 18, strike "CARE" and substitute  
2 HEALTH-CARE SERVICES".

3 Page 5, after line 19 insert:

4 "(4) "END-OF-LIFE HEALTH-CARE SERVICES" MEANS ANY MEDICAL,  
5 SURGICAL, PREVENTIVE, COUNSELING, OR REFERRAL SERVICES PROVIDED  
6 TO AN INDIVIDUAL WHO IS NEAR THE END OF LIFE OR WHO HAS A TERMINAL  
7 ILLNESS. "END-OF-LIFE HEALTH-CARE SERVICES" INCLUDES ANY SERVICES  
8 PROVIDED PURSUANT TO ARTICLE 48 OF TITLE 25, PALLIATIVE CARE,  
9 SERVICES IDENTIFIED IN ADVANCE DIRECTIVES, WITHDRAWAL OF  
10 NUTRITION SERVICES, AND HOSPICE CARE.".

11 Renumber succeeding subsections accordingly.

12 Page 6, after line 6 insert:

13 "(6) "LGBTQ HEALTH-CARE SERVICES" MEANS ANY MEDICAL,  
14 SURGICAL, PREVENTIVE, COUNSELING, OR REFERRAL SERVICES THAT ARE  
15 SPECIFICALLY TARGETED TO OR THAT DISPROPORTIONATELY AFFECT  
16 LGBTQ INDIVIDUALS, INCLUDING GENDER-AFFIRMING CARE,  
17 HIV-RELATED CARE, AND FAMILY-BUILDING SERVICES.".

18 Renumber succeeding subsections accordingly.

19 Page 6, after line 12 insert:

20 "(7) "REPRODUCTIVE HEALTH-CARE SERVICES" MEANS ANY  
21 MEDICAL, SURGICAL, PREVENTIVE, COUNSELING, OR REFERRAL SERVICES  
22 RELATING TO THE HUMAN REPRODUCTIVE SYSTEM, INCLUDING SERVICES  
23 RELATING TO CONTRACEPTION, STERILIZATION, PREGNANCY, AND THE  
24 TERMINATION OF A PREGNANCY.".

25 Renumber succeeding subsection accordingly.

26 Page 6, line 23, after "IDENTIFY" insert "REPRODUCTIVE HEALTH-CARE  
27 SERVICES, LGBTQ HEALTH-CARE SERVICES, AND END-OF-LIFE".
