

## SENATE FLOOR AMENDMENT

Second Reading

1 Amend printed bill, page 7, strike lines 3 through 8 and substitute:

2 "(3) (a) ON OR BEFORE JULY 1, 2024, EACH LOCAL EDUCATION  
3 PROVIDER SHALL ESTABLISH A COMPREHENSIVE HARASSMENT PREVENTION  
4 AND RESPONSE PROGRAM THAT IS REASONABLY DESIGNED TO STOP AND  
5 ADDRESS HARASSMENT, PREVENT ITS REOCCURRENCE, REMEDY ITS  
6 EFFECTS AND DETER AND PROTECT STUDENTS FROM HARASSMENT. THE  
7 PROGRAM MUST:

8 (I) INVESTIGATE OR ADDRESS HARASSMENT AND BEHAVIORS THAT,  
9 IF NOT CORRECTED, MAY BECOME HARASSMENT;

10 (II) TAKE ACTION THAT IS REASONABLY DESIGNED TO  
11 EFFECTIVELY END THE HARASSMENT;

12 (III) REMEDY THE EFFECTS OF HARASSMENT; AND

13 (IV) PROVIDE TRAINING AND NOTICE TO STAFF, STUDENTS AND  
14 PARENTS OR LEGAL GUARDIANS AS REQUIRED BY SUBSECTION (3)(b) OF  
15 THIS SECTION."

16 Page 7, line 9, strike "POLICY MUST BE" and substitute "~~SCHOOL~~ LOCAL  
17 EDUCATION PROVIDER SHALL PROVIDE NOTICE ABOUT THE PROGRAM TO  
18 STUDENTS AND STAFF THAT IS".

19 Page 7, line 10, strike "INCLUDE" and substitute "INCLUDES".

20 Page 8, strike line 7 through 12, and substitute:

21 "(VI) LOCAL EDUCATION PROVIDERS ARE ENCOURAGED TO  
22 INCLUDE PROVISIONS IN THE PROGRAM THAT EXTEND PROTECTIONS FOR A  
23 STUDENT WHO REPORTS HARASSMENT OR DISCRIMINATION FOR A SCHOOL  
24 POLICY VIOLATION BY THE STUDENT RELATED TO THE INCIDENT, FOR ANY  
25 REASON, INCLUDING: ENGAGING IN REASONABLE SELF-DEFENSE AGAINST  
26 THE RESPONDENT, CONSENSUAL SEXUAL ACTIVITY, DRUG USE, ALCOHOL  
27 USE, OR TRUANCY; AND".

28 Page 8, line 18, strike "THE POLICY" insert "THE NOTICE REQUIRED BY  
29 SUBSECTION (3)(b) OF THIS SECTION".
