4 **30-28-211. Energy efficient building codes - legislative**
5 **declaration - definitions.** (2) As used in this section, unless the context
6 otherwise requires:

7 (a.5) "COLORADO PLUMBING CODE" HAS THE MEANING SET FORTH
8 IN SECTION 12-155-103 (5).

9 (b.8) "NATIONAL ELECTRICAL CODE" HAS THE MEANING SET FORTH
10 IN SECTION 12-115-103 (8).

11 (3.5) (e) NOTWITHSTANDING THE TIMING REQUIREMENT OF
12 SUBSECTION (3.5)(a) OF THIS SECTION, A BOARD OF COUNTY
13 COMMISSIONERS MAY COMPLY WITH SUBSECTION (3.5)(a) OF THIS SECTION
14 WHEN THE BOARD ADOPTS ONE OR MORE BUILDING CODES OTHER THAN
15 THE NATIONAL ELECTRICAL CODE AND THE COLORADO PLUMBING CODE,

5 **31-15-602. Energy efficient building codes - legislative**
6 **declaration - definitions - repeal.** (2) As used in this section, unless the
7 context otherwise requires:

8 (a.5) "COLORADO PLUMBING CODE" HAS THE MEANING SET FORTH
9 IN SECTION 12-155-103 (5).

10 (b.8) "NATIONAL ELECTRICAL CODE" HAS THE MEANING SET FORTH
11 IN SECTION 12-115-103 (8).

12 (3.5) (d) NOTWITHSTANDING THE TIMING REQUIREMENT OF
13 SUBSECTION (3.5)(a) OF THIS SECTION, A GOVERNING BODY OF A
14 MUNICIPALITY MAY COMPLY WITH SUBSECTION (3.5)(a) OF THIS SECTION
15 WHEN THE BODY ADOPTS ONE OR MORE BUILDING CODES OTHER THAN THE
16 NATIONAL ELECTRICAL CODE AND THE COLORADO PLUMBING CODE, OR BY
17 JUNE 30, 2026, WHICHEVER IS EARLIER, IF:

18 (I) THE GOVERNING BODY OF THE MUNICIPALITY ADOPTS OR
19 UPDATES:

20 (A) THE NATIONAL ELECTRICAL CODE BY REFERENCE WHEN
21 ADOPTED OR UPDATED BY THE STATE ELECTRICAL BOARD; OR

22 (B) THE COLORADO PLUMBING CODE BY REFERENCE WHEN
23 ADOPTED OR UPDATED BY THE STATE PLUMBING BOARD; AND

33 ELECTRICAL CODE AND THE COLORADO PLUMBING CODE, OR BY JUNE 30,
34 2030, WHICHEVER IS EARLIER, IF:

35 (I) THE GOVERNING BODY OF A MUNICIPALITY ADOPTS OR
36 UPDATES:

37 (A) THE NATIONAL ELECTRICAL CODE BY REFERENCE WHEN
38 ADOPTED OR UPDATED BY THE STATE ELECTRICAL BOARD; OR

39 (B) THE COLORADO PLUMBING CODE BY REFERENCE WHEN
40 ADOPTED OR UPDATED BY THE STATE PLUMBING BOARD; AND

41 (II) THE ADOPTION OR UPDATE OF THE NATIONAL ELECTRICAL
42 CODE OR THE COLORADO PLUMBING CODE OCCURS ON A TIMING CYCLE
43 DIFFERENT FROM THE SCHEDULED ADOPTION OR UPDATE OF ONE OR MORE

1 BUILDING CODES OTHER THAN THE NATIONAL ELECTRICAL CODE OR THE
2 COLORADO PLUMBING CODE.".
