36 include a notice filed by a professional person pursuant to section
37 27-65-109 (10).

21 treatment of a mental health disorder pursuant to section 27-65-109 (10),
22 or for long-term care and treatment of a mental health disorder pursuant
23 to section 27-65-110; and

24 **SECTION 11.** In Colorado Revised Statutes, 25-3-102.1, **amend**
25 (1)(c) as follows:

26 **25-3-102.1. Deemed status for certain facilities.** (1) (c) Upon
27 submission of a completed application for license renewal, the department
28 of public health and environment shall accept proof of the accreditation
29 in lieu of licensing inspections or other requirements. Nothing in this
30 section exempts an accredited health facility from inspections or from
31 other forms of oversight by the department as necessary to ensure public
32 health and safety. Nothing in this section prevents the department of
33 public health and environment from conducting an inspection of a
34 hospital or other health facility described in section 25-3-101 to
35 investigate a complaint regarding the provisions of section 27-65-106,
36 27-65-107, **27-65-108.5**, 27-65-109, 27-65-110, or 27-65-119 to the
37 extent the complaint is applicable to health facilities licensed by the
38 department of public health and environment.

41 **26-20-103. Basis for use of restraint or seclusion.** (3) In
42 addition to the circumstances described in subsection (1) of this section,
43 a facility, as defined in section 27-65-102, that is designated by the

1 commissioner of the behavioral health administration in the state
2 department to provide treatment pursuant to section 27-65-106,
3 27-65-108, ~~27-65-108.5~~, 27-65-109, or 27-65-110 to an individual with
4 a mental health disorder, as defined in section 27-65-102, may use
5 seclusion to restrain an individual with a mental health disorder when the
6 seclusion is necessary to eliminate a continuous and serious disruption of
7 the treatment environment."

10 "SECTION 15. In Colorado Revised Statutes, 27-65-112, **amend**
11 **as it will become effective July 1, 2024**, (1) as follows:

12 **27-65-112. Termination of certification for short-term and**
13 **long-term treatment.** (1) An original or extended certification for
14 short-term treatment issued pursuant to section 27-65-108.5 OR
15 27-65-109, or an order or extension for certification for long-term care
16 and treatment pursuant to section 27-65-110 terminates as soon as the
17 professional person in charge of treatment of the respondent and the BHA
18 determine the respondent has received sufficient benefit from the
19 treatment for the respondent to end involuntary treatment. Whenever a
20 certification or extended certification is terminated pursuant to this
21 section, the professional person in charge of providing treatment shall
22 notify the court in writing within five days after the termination."

26 **as it will become effective July 1, 2023**, (1) introductory portion as
27 follows:

28 **27-65-119. Rights of respondents certified for short-term**
29 **treatment or long-term care and treatment.** (1) ~~Each~~ EACH respondent
30 certified for short-term treatment or long-term care and treatment on an
31 inpatient basis pursuant to sections ~~27-65-108.5~~, 27-65-109, and
32 27-65-110 has the following rights and shall be advised of such rights by
33 the facility:

12 concerns and filing complaints with appropriate regulatory or oversight
13 agencies relating to inappropriate care, a procedure for an emergency
14 mental health hold pursuant to section 27-65-106, a certification for
15 short-term treatment pursuant to section 27-65-108.5 OR 27-65-109, or a
16 certification for long-term care and treatment pursuant to section
17 27-65-110;".
