

SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Health & Human Services.

HB23-1077 be amended as follows:

- 1 Amend reengrossed bill, page 3, line 8, strike "IS RECOGNIZED BY AND".
- 2 Page 3, line 9, strike "TEAM;" and substitute "TEAM, AND THE STUDENT'S
- 3 OR TRAINEE'S ROLE IN PERFORMING AN INTIMATE EXAMINATION FOR
- 4 EDUCATIONAL OR TRAINING PURPOSES HAS BEEN SHARED WITH THE
- 5 PATIENT;".
- 6 Page 3, line 13, strike "(I) A LICENSEE MAY PERFORM" and substitute
- 7 "THE REQUIREMENTS OF SUBSECTION (1)(a) OF THIS SECTION DO NOT
- 8 APPLY TO:
- 9 (I) A LICENSEE WHO PERFORMS".
- 10 Page 3, line 15, strike "ONLY".
- 11 Page 3, strike lines 17 through 19 and substitute "LIFE OR WELL-BEING OF
- 12 THE PATIENT, BUT THE LICENSEE MUST MAKE A RECORD OF".
- 13 Page 3, line 24, strike "UNCONSCIOUS." and substitute "UNCONSCIOUS;
- 14 OR".
- 15 Page 3, strike lines 25 through 27.
- 16 Page 4, strike lines 1 through 3 and substitute:
- 17 "(II) A LICENSEE WHO HAS OBTAINED THE PATIENT'S CONSENT TO
- 18 PROVIDE HEALTH CARE THAT INCLUDES AN INTIMATE EXAMINATION IF THE
- 19 LICENSEE HAS INFORMED THE PATIENT OF THE INTIMATE EXAMINATION IN
- 20 THE COURSE OF OBTAINING THE PATIENT'S CONSENT TO THE HEALTH
- 21 CARE."
- 22 Page 5, lines 19 and 20, strike "A REGULATOR FOR USE BY LICENSEES,"
- 23 and substitute "THE DEPARTMENT OF PUBLIC HEALTH AND ENVIRONMENT,
- 24 IN ACCORDANCE WITH SECTION 25-3-130 (3), FOR USE BY HEALTH-CARE
- 25 PROVIDERS,".
- 26 Page 5, strike lines 22 through 27.
- 27 Reletter succeeding paragraph accordingly.
- 28 Page 6, line 5, after "COMPLAINT" insert "REGARDING A VIOLATION OF
- 29 THIS SECTION".
