

HOUSE COMMITTEE OF REFERENCE AMENDMENT  
Committee on Transportation, Housing & Local Government.  
HB23-1147 be amended as follows:

1 Amend printed bill, page 6, after line 24 insert:

2        "(2) "COUNTY OFFICE" MEANS THE OFFICE OF A COUNTY CLERK  
3 AND RECORDER THAT ISSUES DRIVER'S LICENSES AND PERFORMS DRIVING  
4 EXAMINATIONS.".

5 Renumber succeeding subsections accordingly.

6 Page 10, strike lines 10 through 12 and substitute:

7        "(a) BY JULY 1, 2025, IN AREAS THAT DO NOT HAVE A  
8 THIRD-PARTY PROVIDER WITHIN SIXTY MILES FROM A DEPARTMENT OFFICE  
9 THAT ISSUES DRIVER'S LICENSES, PROVIDE DRIVING EXAMINATIONS AT  
10 LEAST ONCE EACH WEEK THAT DEMONSTRATE THE ABILITY OF AN  
11 APPLICANT FOR A DRIVER'S LICENSE TO DRIVE A MOTOR VEHICLE WITH  
12 APPROPRIATE CARE AND CONTROL; AND".

13 Page 10, line 25, after "PROVIDER" insert "OR COUNTY OFFICE".

14 Page 10, line 26, after "PROVIDER" insert "OR COUNTY OFFICE".

15 Page 11, after line 23 insert:

16        "(d) THE ADEPT ENTERPRISE SHALL SET THE REIMBURSEMENT  
17 RATE FOR COUNTY OFFICES AT A STANDARD RATE THAT IS BASED ON THE  
18 AVERAGE COST IN COLORADO OF COUNTY OFFICES PROVIDING DRIVING  
19 EXAMINATIONS.".

20 Page 11, line 27, after "PROVIDERS" insert "OR COUNTY OFFICES".

21 Page 12, strike line 10 and substitute "REIMBURSEMENTS TO THIRD-PARTY  
22 PROVIDERS OR COUNTY OFFICES;".

23 Page 12, after line 10 insert:

24        "(c) THAT A REIMBURSEMENT MUST BE MADE WITHIN THIRTY DAYS  
25 AFTER THE THIRD-PARTY PROVIDER OR COUNTY OFFICE REQUESTS  
26 REIMBURSEMENT; AND".

27 Reletter succeeding paragraph accordingly.

- 1 Page 13, strike lines 16 through 22.
- 2 Renumber succeeding C.R.S. section accordingly.
- 3 Page 1, line 104, after "**PROVIDERS**" insert "**AND COUNTIES**".
- 4 Page 1, strike lines 106 and 107 and substitute "**SETTING**".
