1 Amend reengrossed bill, page 19, line 22, after "**amend**" insert
 2 "(1)(a)(III)(B),".

3 Page 19, line 23, strike "portion and (1)(b.7)" and substitute "portion, and
 4 (1)(b.7); and **add** (1)(a)(III)(C)".

5 Page 19, strike line 25 and substitute: "**- services provided - drop-off**
 6 **locations - definition.** (1) (a) For general elections, each county clerk
 7 and recorder shall designate a minimum number of voter service and
 8 polling centers, as follows:

9 (III) For counties with at least ten thousand but fewer than
 10 thirty-seven thousand five hundred active electors:

11 (B) On election day, at least three voter service and polling
 12 centers; EXCEPT THAT, IF FIFTY PERCENT OR MORE OF THE ACTIVE
 13 ELECTORS IN THE COUNTY RESIDE IN A SINGLE POPULATION CENTER OR
 14 WITHIN THE AREA OF A SINGLE ZIP CODE IN THE COUNTY, AT LEAST TWO
 15 VOTER SERVICE AND POLLING CENTERS IF APPROVED BY THE SECRETARY
 16 OF STATE PURSUANT TO SUBSECTION (1)(a)(III)(C) OF THIS SECTION.

17 (C) A COUNTY CLERK AND RECORDER IN A COUNTY DESCRIBED IN
 18 THIS SUBSECTION (1)(a)(III) MUST APPLY TO THE SECRETARY OF STATE TO
 19 REDUCE THE NUMBER OF VOTER SERVICE AND POLLING CENTERS
 20 PURSUANT TO SUBSECTION (1)(a)(III)(B) OF THIS SECTION. THE
 21 APPLICATION MUST INCLUDE DATA SHOWING THE PERCENTAGE OF THE
 22 COUNTY'S ACTIVE ELECTORS THAT RESIDE IN A SINGLE POPULATION
 23 CENTER OR ZIP CODE WITHIN THE COUNTY AND SHOWING THAT THREE
 24 VOTER SERVICE AND POLLING CENTERS WERE NOT REQUIRED FOR THE
 25 NUMBER OF ACTIVE ELECTORS IN THE COUNTY DURING THE LAST
 26 ELECTION. THE APPLICATION MUST STATE THAT AFTER CONSIDERATION OF
 27 THE FACTORS SET FORTH IN SUBSECTION (1)(c)(I) OF THIS SECTION, THE
 28 CLERK AND RECORDER HAS DETERMINED THAT TWO VOTER SERVICE AND
 29 POLLING CENTERS WILL ADDRESS THE NEEDS OF THE COUNTY. THE
 30 APPLICATION MUST BE INCLUDED WITH AN ELECTION PLAN FILED WITH THE
 31 SECRETARY OF STATE PURSUANT TO SECTION 1-7.5-105, AND THE
 32 SECRETARY OF STATE SHALL ACT ON THE APPLICATION AS PART OF
 33 APPROVING OR DISAPPROVING AN ELECTION PLAN PURSUANT TO SECTION
 34 1-7.5-105 (2). THE SECRETARY OF STATE SHALL DEVELOP DETAILED
 35 GUIDELINES FOR THE APPLICATION SPECIFIED IN THIS SUBSECTION
 36 (1)(a)(III)(C) AND THE DATA REQUIRED TO BE SUBMITTED WITH THE
 37 APPLICATION.
