HB22-1157 be amended as follows:

1 Amend reengrossed bill, page 7, after line 24 insert:

2 "SECTION 3. In Colorado Revised Statutes, 25-4-2206, **amend**
3 (4) as follows:

4 **25-4-2206. Health equity commission - creation - repeal.**

5 (4) (a) The office shall provide staff to the commission.

6 (b) IN ADDITION TO ANY OTHER DUTIES, UNDER THE DIRECTION OF
7 THE COMMISSION, COMMISSION STAFF SHALL DETERMINE, IN ACCORDANCE
8 WITH APPLICABLE FEDERAL AND STATE DATA PRIVACY LAWS, RULES, AND
9 REGULATIONS AND FEDERAL CONTRACTS, THE SCOPE OF DATA AND THE
10 MANNER OF DATA SHARING FOR PURPOSES OF REQUIRED REPORTING
11 CONCERNING HEALTH DISPARITIES AND INEQUITIES PURSUANT TO SECTION
12 25-4-2205 (2.5), IN ORDER TO MINIMIZE DUPLICATION AND TO PROTECT
13 SENSITIVE OR PERSONALLY IDENTIFYING INFORMATION.

14 **SECTION 4.** In Colorado Revised Statutes, **repeal** 25-2-113.8
15 (2)(a).

16 **SECTION 5.** In Colorado Revised Statutes, 25-2-113.8, **add** (1.5)
17 and (2)(c) as follows:

18 **25-2-113.8. Birth certificate modernization act - new birth**
19 **certificate following a change in gender designation - short title -**
20 **definition.** (1.5) AS USED IN THIS SECTION, UNLESS THE CONTEXT
21 OTHERWISE REQUIRES, "REPORT OF BIRTH" MEANS AN ELECTRONIC OR
22 PAPER DOCUMENT CONTAINING INFORMATION RELATED TO A VITAL EVENT
23 SUBMITTED BY A PERSON OR ENTITY REQUIRED TO SUBMIT THE
24 INFORMATION FOR PURPOSES OF REGISTERING A VITAL STATISTIC.

25 (2) (c) A REPORT OF BIRTH, FILED WITH THE STATE REGISTRAR,
26 MUST BE COMPLETED IN ACCORDANCE WITH THE INFORMATION REQUIRED
27 BY THE NATIONAL CENTER FOR HEALTH STATISTICS IN THE CENTERS FOR
28 DISEASE CONTROL AND PREVENTION IN THE FEDERAL DEPARTMENT OF
29 HEALTH AND HUMAN SERVICES."

30 Renumber succeeding sections accordingly.
