23 MUST APPLY TO ALL STATE AND COUNTY, DISTRICT, AND MUNICIPAL
24 PUBLIC HEALTH AGENCIES, AS DESCRIBED IN SECTION 25-1-506; PUBLIC
25 HEALTH DIRECTORS, AS DESCRIBED IN SECTION 25-1-509; AND OTHER
26 PERSONS REQUIRED TO COLLECT AND REPORT DATA TO THE
27 DEPARTMENT".
- 28 Page 5 of the bill, line 11, strike "PROVIDED" and substitute
29 "PUBLISHED".
