

HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Energy & Environment.

HB22-1249 be amended as follows:

1 Amend printed bill, page 2, line 6, strike "(1) (a)" and substitute
2 "(1) (a) (I)".

3 Page 3, after line 7 insert:

4 "(II) ON OR BEFORE JULY 1, 2024, THE OFFICE SHALL:

5 (A) PUBLISH A DRAFT ROADMAP;

6 (B) POST THE DRAFT ROADMAP ON ITS WEBSITE AND PROVIDE A
7 MECHANISM FOR RECEIVING PUBLIC COMMENT ON THE DRAFT ROADMAP;
8 AND

9 (C) ALLOW PUBLIC COMMENT ON THE DRAFT ROADMAP FOR AT
10 LEAST THIRTY DAYS.

11 (III) THE OFFICE, IN COLLABORATION WITH THE DEPARTMENT AND
12 THE RESILIENCY OFFICE, SHALL REVIEW ANY COMMENTS RECEIVED ABOUT
13 THE DRAFT ROADMAP."

14 Page 3, strike lines 24 and 25 and substitute "COMMUNITIES;

15 (F) REPRESENTATIVES OF COMMUNITIES AT THE HIGHEST RISK OF
16 POWER OUTAGES AS DESCRIBED IN SUBSECTION (2)(b)(IV) OF THIS
17 SECTION;

18 (G) REPRESENTATIVES OF MUNICIPAL, COUNTY, OR CITY AND
19 COUNTY GOVERNMENTS;

20 (H) REPRESENTATIVES OF COMMERCIAL AND INDUSTRIAL UTILITY
21 CUSTOMERS;

22 (I) REPRESENTATIVES OF LABOR ORGANIZATIONS; AND

23 (J) REPRESENTATIVES FROM THE DEPARTMENT OF PUBLIC SAFETY
24 CREATED IN SECTION 24-33.5-103 (1), REPRESENTATIVES FROM THE
25 DIVISION OF HOMELAND SECURITY AND EMERGENCY MANAGEMENT
26 CREATED IN SECTION 24-33.5-1603 (1), AND OTHER REPRESENTATIVES OF
27 CRITICAL INFRASTRUCTURE IN THE STATE.

28 (III) IN ADDITION TO SEEKING INPUT FROM THE GROUPS LISTED IN
29 SUBSECTION (1)(b)(II) OF THIS SECTION, THE OFFICE, DEPARTMENT, AND
30 RESILIENCY OFFICE, WHEN DEVELOPING THE ROADMAP, SHALL TAKE INTO
31 CONSIDERATION UTILITY WILDFIRE MITIGATION PLANS."

32 Page 4, strike lines 1 through 6 and substitute "REGARDING WHETHER,
33 HOW, AND IN WHAT MANNER MICROGRIDS MAY BE USED TO:

34 (A) HELP HARDEN THE GRID AND IMPROVE GRID RESILIENCE AND
35 RELIABILITY FOR INDIVIDUAL CUSTOMERS;

36 (B) HELP HARDEN THE GRID AND IMPROVE GRID RESILIENCE AND
37 RELIABILITY FOR COMMUNITIES AND MULTIPLE CUSTOMERS; AND

1 (C) DELIVER AND MANAGE ELECTRICITY AND THE NECESSARY
2 INFRASTRUCTURE IN CIRCUMSTANCES WHERE EXTENDING DISTRIBUTION
3 INFRASTRUCTURE MAY NOT BE PRACTICABLE."

4 Page 5, strike line 25 and substitute:

5 "(D) IMPROVE CUSTOMER CHOICE, INCLUDING COST IMPACTS AND
6 BENEFITS TO THE CUSTOMER SERVED BY THE MICROGRID AND TO OTHER
7 CUSTOMERS SERVED BY THE UTILITY;

8 (E) BE INCLUDED IN DISTRIBUTED ENERGY RESOURCE PLANNING;"

9 Reletter succeeding sub-subparagraphs accordingly.

10 Page 6, after line 6 insert:

11 "(VII) EXPLORE OPPORTUNITIES TO FOSTER PUBLIC-PRIVATE
12 PARTNERSHIPS, INCLUDING UTILITY PILOT PROGRAMS AND
13 COST-RECOVERY MECHANISMS TO SUPPORT UTILITY RESILIENCE
14 INITIATIVES;"

15 Renumber succeeding subparagraphs accordingly.
