HB22-1412 be amended as follows:

- 1 Amend printed bill, page 7, after line 25 insert:
2 "SECTION 15. In Colorado Revised Statutes, 44-30-302, **amend**
3 (1) introductory portion, (1)(u), and (1)(v); and **add** (1)(w) as follows:
4 **44-30-302. Commission - powers and duties - rules.** (1) In
5 addition to any other powers and duties set forth in this part 3, and
6 notwithstanding the designation of the Colorado limited gaming control
7 commission under section 44-30-201 as a **type 2 transfer** ENTITY, the
8 commission ~~shall~~ nonetheless ~~have~~ HAS the following powers and duties:
9 (u) To demand, at any time when business is being conducted,
10 access to and inspection, examination, photocopying, and auditing of all
11 papers, books, and records of applicants and licensees, on their premises
12 or elsewhere as practicable and in the presence of the licensee or the
13 licensee's agent, pertaining to the gross income produced by any
14 establishment or activity licensed under this article 30; to require
15 verification of income and all other matters affecting the enforcement of
16 the policies of the commission or any provision of this article 30; and to
17 impound or remove all papers, books, and records of applicants and
18 licensees, without hearing, for inspection or examination; ~~and~~
19 (v) To prescribe voluntary alternative methods for the making,
20 filing, signing, subscribing, verifying, transmitting, receiving, or storing
21 of returns or other documents; AND
22 (w) TO DETERMINE WHETHER PERSONS THAT ARE NOT LICENSED
23 BY THE COMMISSION TO CONDUCT SPORTS BETTING OR LIMITED GAMING
24 OPERATIONS ARE OFFERING TO ONE OR MORE MEMBERS OF THE PUBLIC, IN
25 ANY CITY, TOWN, CITY AND COUNTY, OR COUNTY:
26 (I) UNLICENSED SPORTS BETTING OPERATIONS;
27 (II) UNLICENSED INTERNET SPORTS BETTING OPERATIONS; OR
28 (III) UNLICENSED ESTABLISHMENTS THAT ALLOW THE USE OF
29 EQUIPMENT OR DEVICES THAT QUALIFY AS SLOT MACHINES OR ARE USED
30 TO PLAY ROULETTE OR CRAPS.
31 **SECTION 16.** In Colorado Revised Statutes, **add** 44-30-837 as
32 follows:
33 **44-30-837. Conducting gaming activities without a license.**
34 (1) A PERSON SHALL NOT OFFER SPORTS BETTING OR ONE OR MORE
35 GAMES, AUTHORIZED AS "LIMITED GAMING", TO THE PUBLIC WITHOUT
36 POSSESSING THE REQUIRED LICENSE FROM THE COMMISSION TO CONDUCT:
37 (a) SPORTS BETTING OPERATIONS;
38 (b) INTERNET SPORTS BETTING OPERATIONS; OR
39 (c) OPERATIONS USING EQUIPMENT OR DEVICES THAT QUALIFY AS
40 SLOT MACHINES ARE USED TO PLAY ROULETTE OR CRAPS."
