Committee on Judiciary.

SB22-049 be amended as follows:

- 1 Amend printed bill, page 2, line 7, strike "(1)(nn) and (1)(oo)" and
2 substitute "(1)(nn), (1)(oo), and (1)(pp)".
- 3 Page 2, line 15, strike "SECTION 18-6-701 (1)(a)." and substitute "SECTION
4 18-6-701 (1)(a);".
- 5 Page 2, after line 15 insert:
6 "(pp) CRIMINAL INVASION OF PRIVACY, IN VIOLATION OF SECTION
7 18-7-801.".
- 8 Page 5, line 25, strike "PRISON" and substitute "THE DEPARTMENT OF
9 CORRECTIONS".
- 10 Page 9, line 16, strike "PRISON" and substitute "THE DEPARTMENT OF
11 CORRECTIONS".
- 12 Page 14, strike lines 15 through 17 and substitute:
13 (h) (IV) ~~If victim notification is required, the probation officer~~
14 UNLESS THE VICTIM HAS OPTED OUT OF VICTIM NOTIFICATIONS FROM
15 COMMUNITY CORRECTIONS, THE COMMUNITY CORRECTIONS PROGRAM
16 AGENT FOR THE COMMUNITY CORRECTIONS PROGRAM shall provide".
- 17 Page 14, line 21, strike "SECTION 24-4.1-302 (1), IN A" and substitute
18 "SECTION 24-4.1-302 (1). THE COMMUNITY CORRECTIONS PROGRAM
19 AGENT FOR THE COMMUNITY CORRECTIONS PROGRAM SHALL NOTIFY THE
20 PROBATION DEPARTMENT OF THE VICTIM'S POSITION, AND THE PROBATION
21 DEPARTMENT SHALL PROVIDE TIMELY NOTIFICATION TO THE COMMUNITY
22 CORRECTIONS PROGRAM OF THE HEARING DATE, IF A HEARING IS SET.
23 REGARDLESS OF WHETHER A HEARING IS SET, THE PROBATION
24 DEPARTMENT SHALL NOTIFY THE COMMUNITY CORRECTIONS PROGRAM OF
25 THE OUTCOME OF THE OFFENDER'S MOTION FOR EARLY TERMINATION OF
26 A DIRECT SENTENCE TO THE COMMUNITY CORRECTIONS PROGRAM AND THE
27 COMMUNITY CORRECTIONS PROGRAM AGENT SHALL NOTIFY THE VICTIM.".
- 28 Page 14, strike lines 22 and 23.
