SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Local Government.

SB22-145 be amended as follows:

- 1 Amend printed bill, page 6, line 17, after the period insert "THE DIRECTOR
- 2 SHALL ENSURE THAT THE COMPOSITION OF THE COMMITTEE IS RACIALLY,
- 3 ETHNICALLY, AND GEOGRAPHICALLY DIVERSE AND REPRESENTATIVE OF
- 4 THE COMMUNITIES WHERE CRIME IS DISPROPORTIONATELY HIGH."
  
- 5 Page 6, line 18, strike "ELEVEN" and substitute "TWELVE".
  
- 6 Page 6, line 26, strike "POLICY;" and substitute "POLICY AND RESEARCH
- 7 OR EVALUATION OF EFFECTIVE COMMUNITY-BASED SERVICES THAT
- 8 REDUCE CRIME AND VIOLENCE;"
  
- 9 Page 7, strike line 8 and substitute "13-90-107 (1)(k)(II), WITH
- 10 EXPERIENCE IN PROVIDING CULTURALLY RESPONSIVE SERVICES IN
- 11 COMMUNITIES OF COLOR OR A REPRESENTATIVE FROM A
- 12 COMMUNITY-BASED VICTIM SERVICES ORGANIZATION THAT SPECIALIZES
- 13 IN SERVING VICTIMS OF COLOR;"
  
- 14 Page 7, line 10, strike "HEALTH-CARE;" and substitute "HEALTH CARE
- 15 WITH EXPERIENCE IN PROVIDING CULTURALLY RESPONSIVE CARE IN
- 16 COMMUNITIES OF COLOR AND UNDERSERVED POPULATIONS;"
  
- 17 Page 7, line 12, strike "SYSTEM;" and substitute "SYSTEM WITH
- 18 EXPERIENCE IN PROVIDING CULTURALLY RESPONSIVE SERVICES IN
- 19 COMMUNITIES OF COLOR AND UNDERSERVED POPULATIONS;"
  
- 20 Page 7, line 14, strike "AND".
  
- 21 Page 7, strike line 15 and substitute:
- 22 "(I) A MEMBER WHO SPECIALIZES IN VIOLENCE PREVENTION,
- 23 INCLUDING IN COMMUNITIES OF COLOR AND UNDERSERVED POPULATIONS;
- 24 AND
- 25 (J) A COMMUNITY REPRESENTATIVE."
