

HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Transportation & Local Government.

HB22-1162 be amended as follows:

1 Amend printed bill, page 2, line 5, strike "**definition.**" and substitute
2 "**definition - repeal.**", and strike "THE" and substitute "SUBJECT TO THE
3 RULES PROMULGATED UNDER SUBSECTION (8)(c)(II) OF THIS SECTION,
4 THE".

5 Page 2, line 18, strike "DEPARTMENT MAY" and substitute "DEPARTMENT,
6 IN CONSULTATION WITH THE COLORADO STATE PATROL, SHALL".

7 Page 2, line 19, after the period, add "THE RULES MUST:

8 (A) SET STANDARDS NECESSARY FOR THE SAFE USE OF DIGITAL
9 NUMBER PLATES;

10 (B) ESTABLISH REQUIREMENTS FOR PRODUCT OVERSIGHT AND
11 CONSUMER SUPPORT;

12 (C) ESTABLISH REQUIREMENTS FOR PRODUCT SIZE, DESIGN,
13 DISPLAY, AND FUNCTIONALITY;

14 (D) ESTABLISH A PROCESS FOR APPROVAL OF DIGITAL NUMBER
15 PLATES PRODUCTS FOR STATEWIDE USE;

16 (E) SET PROTOCOLS FOR DATA SHARING, PRIVACY, AND SECURITY;

17 (F) ESTABLISH A PROCESS FOR REVOKING THE AUTHORITY TO USE
18 A DIGITAL NUMBER PLATE;

19 (G) SET TESTING REQUIREMENTS TO APPROVED DIGITAL NUMBER
20 PLATES;

21 (H) SET A PROCESS TO DETERMINE THE TYPES OF NUMBER PLATES
22 THAT ARE ELIGIBLE TO USE AS DIGITAL NUMBER PLATES; AND

23 (I) SET REPORTING REQUIREMENTS FOR COMPANIES THAT SELL
24 DIGITAL NUMBER PLATES TO THE PUBLIC.

25 (III) (A) THE DEPARTMENT SHALL REVIEW THE IMPLEMENTATION
26 OF DIGITAL PLATES WITHIN ONE YEAR AFTER THE EFFECTIVE DATE OF THE
27 RULES ADOPTED IN ACCORDANCE WITH SUBSECTION (8)(c)(II). IN
28 PERFORMING THE REVIEW, THE DEPARTMENT SHALL OBTAIN COMMENTS
29 AND RECOMMENDATIONS FROM THE COLORADO STATE PATROL AND
30 PERSONS WHO ARE INTERESTED IN DIGITAL NUMBER PLATES. WITHIN ONE
31 YEAR AFTER PERFORMING THE REVIEW, THE DEPARTMENT SHALL PREPARE
32 A REPORT BASED ON THE REVIEW AND SUBMIT THE REPORT TO THE
33 TRANSPORTATION LEGISLATION REVIEW COMMITTEE, CREATED IN SECTION
34 43-2-145.

35 (B) THIS SUBSECTION (8)(c)(III) IS REPEALED, EFFECTIVE JULY 1,
36 2025".
