7 AGENCY, GAMETE BANK, OR FERTILITY CLINIC FURTHERS THE ABILITY OF
8 THESE DONOR-CONCEIVED PERSONS TO ESTABLISH THIS CONTACT.".

30 AND MATCHES POTENTIAL GAMETE DONORS WITH POTENTIAL RECIPIENTS
31 IN, OR WHO ARE RESIDENTS OF, COLORADO, AND THE POTENTIAL
32 RECIPIENTS AND GAMETE DONORS ARE UNKNOWN TO EACH OTHER.
33 (8) "GAMETE AGENCY, GAMETE BANK, OR FERTILITY CLINIC"
34 MEANS ANY ONE OF SUCH ENTITIES AS DEFINED IN THIS SECTION.

1 (9) "GAMETE BANK" MEANS AN ENTITY OR ORGANIZATION THAT
2 COLLECTS GAMETES FROM A DONOR OR RECEIVES EMBRYOS AND PROVIDES
3 GAMETES OR EMBRYOS TO A RECIPIENT PARENT OR PARENTS OR THE
4 RECIPIENT PARENT'S MEDICAL PROVIDER WHEN THE RECIPIENT AND DONOR
5 ARE UNKNOWN TO EACH OTHER, AND THAT IS LOCATED WITHIN OR
6 OUTSIDE OF COLORADO AND PROVIDES GAMETES OR EMBRYOS TO A
7 RECIPIENT PARENT OR PARENTS IN OR WHO ARE RESIDENTS OF
8 COLORADO."

12 THE DONOR."
