SB25-194 be amended as follows:

- 1    Amend printed bill, page 24, line 12, after "(3)(a)(VI)," insert "(3)(b)"
- 2    introductory portion,".
  
- 3    Page 25, line 15, strike "dentist:" and substitute "dentist OR THE DIRECT" 4    SUPERVISION OF A LICENSED DENTAL THERAPIST OR A LICENSED DENTAL" 5    HYGIENIST:".
  
- 6    Page 27, line 15, before "and" insert "(1)(g)(V),".
  
- 7    Page 28, line 9, strike "CONCERN;" and substitute "CONCERN PERTINENT" 8    TO THE SCOPE OF PRACTICE FOR DENTAL HYGIENE;".
  
- 9    Page 29, lines 24 and 25, strike "AND OTHER SILVER FLUORIDES." and" 10    substitute "OTHER SILVER FLUORIDES, HYDROXYAPATITE REGENERATION" 11    MEDICAMENTS USED FOR REPAIRING CAVITIES, AND ALTERNATIVES FOR" 12    STRENGTHENING TEETH AND PREVENTING AND ARRESTING TOOTH" 13    DECAY.".
  
- 14    Page 30, line 10, strike "and" and substitute "and".
  
- 15    Page 30, after line 17 insert:  
16         "(V) A DENTAL HYGIENIST MAY PRESCRIBE, DISPENSE, AND" 17         ADMINISTER NONNARCOTIC ANALGESICS, ANTI-INFLAMMATORIES, AND" 18         ANTIBIOTICS WITHIN THE PARAMETERS OF A WRITTEN ARTICULATED PLAN," 19         WITH THE AUTHORIZATION OF THE SUPERVISING DENTIST, AND UPON" 20         COMPLETION OF A POSTSECONDARY COURSE OR CONTINUING EDUCATION" 21         COURSE DEVELOPED AT THE POSTSECONDARY LEVEL THAT SATISFIES THE" 22         REQUIREMENTS ESTABLISHED BY THE BOARD AND THAT PROVIDES" 23         INSTRUCTION ON THE USE AND LIMITATIONS OF NONNARCOTIC" 24         ANALGESICS, ANTI-INFLAMMATORIES, AND ANTIBIOTICS.".
  
- 25    Page 32, line 17, strike "(c)" and substitute "(c) (I)".
  
- 26    Page 32, line 23, strike "OLDER OR TO DENTAL PATIENTS OF" and" 27    substitute "OLDER.".
  
- 28    Page 32, strike lines 24 and 25 and substitute:  
29         "(II) DENTISTS AND DENTAL HYGIENISTS:"  
30         (A) ARE NOT AUTHORIZED TO PROVIDE MEDICAL EXEMPTIONS FOR" 31         ANY REQUIRED IMMUNIZATIONS;"  
32         (B) SHALL ENTER ALL IMMUNIZATION-RELATED ADMINISTRATION

1 INFORMATION INTO THE COLORADO IMMUNIZATION INFORMATION SYSTEM  
2 CREATED PURSUANT TO PART 24 OF ARTICLE 4 OF TITLE 25; AND  
3 (C) WHO ADMINISTER IMMUNIZATIONS SHALL DISCLOSE THEIR  
4 MEDICAL TRAINING RELATED TO PEDIATRIC ADMINISTRATION, INCLUDING  
5 THE ABILITY TO MANAGE SIDE EFFECTS OR ADVERSE OUTCOMES, TO  
6 PATIENTS AS PART OF THE PATIENT CONSENT PROCESS.".
