

SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Health & Human Services.

SB25-194 be amended as follows:

1 Amend printed bill, page 5, strike lines 20 through 27.

2 Strike page 6.

3 Page 7, strike lines 1 through 5 and substitute "(1)(b)(II)(A) and (5) as
4 follows:

5 **"12-220-105. Colorado dental board - qualifications of board**
6 **members - quorum - panel - rules - review of functions - repeal of**
7 **article - repeal.** (1) (b) (II) (A) Effective July 1, 2031, the board consists
8 of seven dentist members, ~~two~~ ONE dental therapist ~~members, two~~
9 MEMBER, THREE dental hygienist members, and two members from the
10 public at large; EXCEPT THAT THE DENTAL THERAPIST SEAT SHALL REMAIN
11 OPEN AND A DENTAL THERAPIST MEMBER SHALL NOT BE APPOINTED UNTIL
12 THERE ARE AT LEAST ONE HUNDRED DENTAL THERAPISTS ACTIVELY
13 ENGAGED IN CLINICAL PRACTICE IN THIS STATE. The governor shall
14 appoint each member for a term of four years, and each member must
15 have the qualifications provided in this article 220. A member shall not
16 serve more than two consecutive terms of four years. Each board member
17 holds office until the member's term expires or until the governor
18 appoints a successor."

19 Page 9, lines 8 and 9, strike "12-220-503 OR 12-220-508 (2);" and
20 substitute "12-220-503 (1)(g)(V) OR 12-220-508 (1)(b), (1)(c)(VII), OR
21 (2);".

22 Page 13, line 13, after "(1)(c)," insert "(1)(d),".

23 Page 14, after line 8 insert:

24 "(d) Furnishes, supplies, constructs, reproduces, or repairs ~~any~~ A
25 prosthetic denture, bridge, appliance, or other structure to be worn in the
26 human mouth or upon the jaws, maxillofacial area, or adjacent and
27 associated structures other than on the ~~written~~ DENTAL laboratory work
28 order of a duly licensed and practicing dentist;"

29 Page 18, line 22, after "renew" insert "OR REINSTATE".

30 Page 21, after line 9 insert:

31 **"SECTION 15.** In Colorado Revised Statutes, 12-220-405,
32 **amend** (1)(a) introductory portion as follows:

33 **12-220-405. Application for dental hygienist license - fee.**

- 1 (1) Every person who desires to qualify for practice as a dental hygienist
2 within this state must file with the board:
3 (a) ~~A written~~ AN application for a license, IN A FORMAT APPROVED
4 BY THE BOARD, on which application the applicant shall list:".
- 5 Renumber succeeding sections accordingly.
- 6 Page 32, strike lines 8 and 9 and substitute:
7 "(e) PLACING INTERIM THERAPEUTIC RESTORATIONS PURSUANT TO
8 SECTION 12-220-505; AND".
- 9 Reletter succeeding paragraph accordingly.
- 10 Page 34, line 18, strike "COMMUNICATIONS" and substitute
11 "COMMUNICATION".
- 12 Page 35, line 2, after "portion," insert "(1)(a)(VIII),".
- 13 Page 35, after line 7 insert:
14 "(VIII) Repair ~~defective~~ prosthetic devices.".
