

HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Energy & Environment.

HB22-1244 be amended as follows:

1 Amend printed bill, page 21, strike lines 2 through 16 and substitute:

2 **"(7) Emission control regulations - rules.** (a) NO LATER THAN
3 JULY 1, 2025, THE COMMISSION SHALL ADOPT EMISSION CONTROL
4 REGULATIONS BY RULE FOR EACH PRIORITY TOXIC AIR CONTAMINANT. THE
5 EMISSION CONTROL REGULATIONS SHALL BE DESIGNED TO REDUCE
6 EMISSIONS THROUGH THE APPLICATION OF BEST AVAILABLE CONTROL
7 TECHNOLOGY.

8 (b) IN DETERMINING THE EMISSION CONTROL REGULATIONS,".

9 Renumber succeeding subsections accordingly.

10 Page 21, strike lines 18 through 27 and substitute:

11 "(I) ANY EMISSION CONTROL REGULATIONS ADOPTED FOR
12 PRIORITY TOXIC AIR CONTAMINANTS IN OTHER STATES OR JURISDICTIONS;
13 (II) THE EMISSION LEVELS OF A PRIORITY TOXIC AIR CONTAMINANT
14 AND ANY ASSOCIATED IMPACTS OF SUCH EMISSION LEVELS ON
15 CONCENTRATIONS OF THE PRIORITY TOXIC AIR CONTAMINANT IN THE
16 AMBIENT AIR;

17 (III) THE TYPES AND LEVELS OF PRIORITY TOXIC AIR
18 CONTAMINANTS THAT DIFFERENT STATIONARY SOURCES AND INDUSTRIES
19 EMIT,".

20 Page 22, line 2, strike "PRESENT OR ANTICIPATED" and strike "HIGH-RISK"
21 and substitute "PRIORITY".

22 Page 22, line 4, strike "AIRBORNE TOXIC CONTROL MEASURES" and
23 substitute "EMISSION CONTROL REGULATIONS".

24 Page 22, line 5, strike "HIGH-RISK" and substitute "PRIORITY".

25 Page 22, strike lines 8 and 9 and substitute:

26 "(VI) THE ANTICIPATED EFFECT OF EMISSION CONTROL
27 REGULATIONS ON LEVELS OF EXPOSURE TO A PRIORITY TOXIC AIR".

28 Page 22, line 14, strike "HIGH-RISK" and substitute "PRIORITY".

29 Page 22, line 16, strike "HIGH-RISK" and substitute "PRIORITY".

30 Page 22, strike line 20 and substitute "EMISSION CONTROL REGULATION.".

31 Page 22, line 21, strike "2032," and substitute "2030,".

1 Page 22, strike lines 26 and 27 and substitute:

2 "(I) ADOPT EMISSION CONTROL REGULATIONS FOR ANY
3 ADDITIONAL PRIORITY TOXIC AIR CONTAMINANTS IDENTIFIED BY THE
4 COMMISSION IN ACCORDANCE WITH SUBSECTION (6)(c)(I) OF THIS
5 SECTION; AND

6 (II) DETERMINE WHETHER TO REVISE THE EXISTING EMISSION
7 CONTROL REGULATIONS IN ACCORDANCE WITH THE CONSIDERATIONS SET
8 FORTH IN SUBSECTION (7)(b) OF THIS SECTION.".

9 Page 23, strike lines 1 through 12.

10 Page 23, line 15, strike "AIRBORNE TOXIC CONTROL MEASURES" and
11 substitute "EMISSION CONTROL REGULATIONS".
