

HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Public & Behavioral Health & Human Services.

HB22-1268 be amended as follows:

1 Amend printed bill page 4, strike lines 13 through 27.

2 Page 5, strike lines 1 through 5 and substitute:

3       **"25.5-4-403.1. Providers - community mental health centers -**  
4 **cost reporting.** (1) FOR THE PURPOSES OF INCREASED PAYMENT  
5 METHODOLOGY TRANSPARENCY, NO LATER THAN MARCH 15, 2023, AND  
6 EACH MARCH 15 THEREAFTER, THE STATE DEPARTMENT SHALL:

7           (a) PUBLISH COST REPORTS FOR COMMUNITY MENTAL HEALTH  
8 CENTERS;

9           (b) ESTABLISH A COST-REPORTING TEMPLATE AND  
10 COST-REPORTING SCHEDULE TO ASSIST PROVIDERS IN PROVIDING COST  
11 REPORTS;

12           (c) REDACT INFORMATION TO MAINTAIN COMPLIANCE WITH STATE  
13 AND FEDERAL LAW INCLUDING, BUT NOT LIMITED TO, PERSONALLY  
14 IDENTIFYING INFORMATION AND PROTECTED HEALTH INFORMATION AS  
15 NECESSARY TO PROTECT THE PRIVACY OF PATIENTS;

16           (d) CREATE A PUBLICLY AVAILABLE WEBSITE THAT PROVIDES  
17 INSIGHT TO MEDICAID MEMBERS, MEDICAID PROVIDERS, AND MEMBERS OF  
18 THE PUBLIC REGARDING BEHAVIORAL HEALTH REIMBURSEMENT RATES.  
19 THE WEBSITE MUST INCLUDE THE FOLLOWING:

20           (I) ALL COMPLETED COST REPORTS FOR EACH BEHAVIORAL HEALTH  
21 SAFETY NET PROVIDER, AS DEFINED IN 27-50-101 (7);

22           (II) AN OVERVIEW OF THE PURPOSE OF THE COST REPORT  
23 DESCRIBED IN THIS SUBSECTION (1);

24           (III) INFORMATION ON HOW TO INTERPRET THE COST REPORTS AND  
25 WHERE TO FIND INFORMATION IN THE COST REPORTS;

26           (IV) AN OVERVIEW OF:

27           (A) HOW REIMBURSEMENT RATES ARE DETERMINED;

28           (B) WHAT CONSTITUTES A REASONABLE AND ALLOWABLE COST;

29 AND

30           (C) HOW VALUE-BASED PAYMENTS IMPACT REIMBURSEMENT  
31 RATES; AND

32           (V) THE STATE DEPARTMENT'S PLAN TO IMPROVE BEHAVIORAL  
33 HEALTH REIMBURSEMENT RATES AND ANNUAL UPDATES TO THE PLAN.".
